Councilman Grotsky made a motion to go into closed session. Councilwoman Sirocchi-Hurley seconded the motion. The motion carried. All present in favor, none opposed. Time 7:04 PM.

The balance of the closed session was postponed, until after the open session, on a motion to open and reconvene from Councilwoman Langschultz. Council President Putrino seconded the motion. The motion carried. All present in favor, none opposed. Time 8:17 PM.

**PUBLIC SESSION:**

Mayor Subrizi called the meeting to order, asked for a moment of silent prayer and/or reflection, and led the flag salute. Mayor Subrizi read the Open Public Meeting Law and Mission Statements and pointed out the fire exits in the Council Chambers.

## **OPEN SESSION:**

### **1. Grants Presentation – Capital Alternatives**

Ms. Casey said the DOT refinancing of the Transportation Trust Fund will result in twenty-eight million in grant funds annually for the next eight years. She said this is seven times the amount normally available. Ms. Casey made a recommendation for two applications. The first would be under the heading of minor bridge or culverts and would include the Floral Court Culvert, the Boulevard over French Brook Culvert and the Steuben Avenue Culvert. She said this would be a discretionary application and could be filed immediately. The second application she recommended would be to finish the remainder of the Boulevard (Section 9) and Graphic Boulevard (Section 6). This application will be announced later in the year.

The Council agreed to pursue both applications. Resolutions for the discretionary application will be prepared for the next meeting.

### **2. Eagle Scout Project – Davidoff**

Eagle Scout candidate Michael Davidoff presented the concept for his proposed Eagle Scout project. He is proposing two campsites on the property at the end of Henley Avenue. Each would consist of three to five tent bases, a fire pit and picnic table. He would like to dedicate one site to the father of a fellow scout who recently passed and the other site to Darren Drake.

Mr. Kelly said he spoke with Mr. Davidoff prior to the meeting. He explained that there are several possible impediments to the plan. He said the property is wet most of the year, it is adjacent to the PSE&G substation and it is not a dedicated park. He said even if it was a dedicated park, people would be prohibited from sleeping there overnight. Mr. Kelly suggested Mr. Davidoff contact local religious and civic organizations to see if he may be able to assist them with a project.

Councilwoman Duffie said Mr. Davidoff may wish to meet with the Beautification Committee as well to discuss a potential project.

### **3. Ambulance Corps Hotspot Request**

Councilwoman Grant referenced the request received from the Ambulance Corps. She said if they were to pay for the service directly it would be \$90 per month for each of the two hotspots. She said if they do it through the Borough's plan it would be \$10 per month for each of the two hotspots. The Administrator asked if they would reimburse the Borough, similar to the arrangement with the Fire Department. Councilwoman Grant said they are asking for the Borough to pick up the cost.

Councilwoman Grant made a motion to approve the request. Councilwoman Duffie seconded the motion. The motion carried on a roll call vote. All present in favor, none opposed.

#### 4. Grant Application Opportunities

Councilwoman Duffie said she spoke with the Administrator regarding the grant opportunities being presented to the Borough by Millennium Strategies. She asked about emails of consent or comments being exchanged with regard to a proposed grant opportunity. Mr. Kelly confirmed that the Council should refrain from discussing the grants via email.

The Administrator said that she receives a number of emails each week that outline possible grant opportunities. She said she generally will forward them to the appropriate department for their consideration. She said if there is interest, she asks the department head to work directly with Millennium on an application. She asked if the Council would want to approve each application prior to it being authorized or if applications, without a financial commitment from the Borough, could be approved without the Council's review. All agreed that applications that do not authorize the expenditure of funds could be authorized without the Council's review.

It was noted that Millennium Strategies said they would provide a monthly report. The Administrator will request the report.

The Administrator referenced the application for funding for a turf field. It was noted that since both of the fields being proposed for New Milford are multi-purpose, we would be ineligible for this grant.

#### 5. Container Request

The Administrator referenced an email received regarding the placement of a dumpster. She said she would contact the homeowner with the information on obtaining the permit.

#### 6. Eagle Scout Project – DeMauro

The Administrator reviewed the request from Eagle Scout candidate Jason DeMauro. Mr. DeMauro has proposed benches and an accessible picnic table with a pathway adjacent to the existing pathway that surrounds Hardcastle Pond.

Councilwoman Grant said she would like to know the dimensions of everything being proposed prior to approving the project. The Council discussed approving the concept, pending the additional information.

Council President Putrino made a motion to approve the concept. Councilwoman Sirocchi-Hurley seconded the motion. The motion carried on a roll call vote. All present in favor, none opposed.

The Administrator will request the additional information and forward it to the Council.

#### 7. Administrator's Report

The Administrator provided an update on the Kennedy Field timeline. Reading from an email from the engineer it was noted that it is possible that the construction can be completed in

three months, but that would be the best case scenario. It was noted that the Field Committee was aware that football and soccer schedules could be affected and they may need to arrange to play somewhere else in the Fall. She said, according to Field Committee Chair George Adelung, the plan would be for the preliminary work such as the submission and approval of product data and shop drawings to be completed prior to the commencement of construction in the middle of June.

Regarding the Suez Field, the Administrator said the engineer's estimate for design came in at \$80,000. She said there is not enough money in the capital improvement fund or the open space fund to cover the cost. She said the bond attorney recommends a bond ordinance for just the design, holding off with the bond ordinance for the construction cost until after the design is complete. She said, with the Council's consent, she will have the bond ordinance prepared for introduction on 3/12. All agreed.

The Administrator said the Budget Committee has been meeting and will meet again on 2/28. She said the budget must be introduced on 3/16 or the next regularly scheduled meeting, which will be 3/26. She said the Committee will have a draft budget for the Council's review at the meeting on 3/12.

The Administrator referenced a letter received from the Art Center of Northern New Jersey, in which they requested permission to place signs, of their own design, at each of the entrances to town. She asked if the request could be approved or if the matter should be listed for discussion at the next meeting. Mayor Subrizi said she would like to see the design prior to approval of the request. Councilwoman Grant said they are looking for permission before going to the expense of designing the signs. She said the signs would not be installed without the Council's approval of the design. All agreed to allow the signs. Councilman Grotsky asked what would be considered the entrances to town. Councilwoman Grant said where the "welcome" signs are located.

## **COUNCIL:**

Councilwoman Sirocchi-Hurley said that according to minutes from a Public Events meeting, the trees at the 9-11 Memorial are supposed to be lit with spotlights. Council President Putrino suggested waiting to place the lights since there will be something added to the area to recognize Darren Drake.

Councilwoman Sirocchi-Hurley said she has been in touch with a number of businesses in town with regard to donations for the Volunteer Party. Councilwoman Langschultz said they will need to fill out a form and provide the committee with a logo for the t-shirt. The committee will meet again on 2/28.

Councilwoman Grant mentioned that new artwork, from the Art Center of Northern New Jersey, has been placed in the entrance hall of the Borough Hall.

Councilwoman Langschultz conveyed thanks from the Fire Department for the approval of the Cost of Living increase to the LOSAP contribution for 2017.

Council President Putrino reported that the Recycle Coach app would be launching soon.

Minutes and attendance were recorded.

A presentation was given by Lauren Odoksta, Jillian Cook, and Jessica Stich on student centered learning. One classroom had a presentation on flexible seating in the classroom with students in attendance and another classroom had a presentation on student led parent teacher conferences with a taped recording of a conference. Parent and students all participated in both presentations.

A second presentation was done by the Boy Scouts who provided a plaque to the BOE for their contributions and help with Nightmare on River Road. They also gave Mr. Torpey of the drama club a \$1000.00 contribution for all of his help with their fundraiser.

A third presentation was provided by BOE member Joseph Steele which highlighted his recent trip to Washington DC where he met with BOE members from across the nation and our legislatures. He provided large emphasis on how affordable housing will greatly affect our school system and scheduled and attended additional meetings with District 39 Assemblywoman Holly Schepisi in reference to Affordable Housing.

After the presentations, the Board followed their agenda and removed F119 from the agenda during the meeting. All other items on the agenda were unanimously approved.

During Mr. Polizzi's report to the Board he discussed school security and that we do have SROs (which is a shared service with Boro) at DEO and NMHS.
