**WORK SESSION:**

Mayor Subrizi read the Open Public Meeting and Mission Statements.

**CLOSED SESSION:**

The record reflects that no closed session took place.

**OPEN SESSION:**

1. PD Headquarters – R.J. Conley

Mayor Subrizi said the PD Headquarters Committee have been meeting with the architect and are now prepared to recommend a plan to the Council; she said it is Scheme 2 in the formal assessment that was provided to the Council.

Mr. Conley provided a brief overview of the plan selected. Mr. Conley said it is a further development of Scheme 1. He said this Scheme is prior to the elimination of the additional 1,800 sq. ft., at which point the building became too small to be usable. He then briefly reviewed the floor plan.

Mayor Subrizi said the purpose of this presentation is to make sure the Council is on the same page with the goal to present it to the public at the next public meeting in August and then take a vote to go out to bid. Mr. Conley said this is just the schematic phase and we should really go through design development which is where the mechanical, electrical and plumbing engineer will be included. He said he would also like to have the borough engineer involved on the site plan and he does not think he will be ready by the end of August. He suggested holding off until the public meeting in September for the presentation to the public. He said at that meeting he will be asking the Council for permission to proceed to the full set of construction plans.

Mr. Conley said if there is anything that anyone would like them to consider to please make a list and forward it through either the Mayor or Councilman Putrino so they can be prepared to respond when they come back in September.

Councilman Putrino mentioned the addition of a 20' by 8' slab to provide for the relocation of the gas tanks from the DPW.

Councilman Cabrera asked about the parking behind the building and asked how far out the lot is proposed to go. Mr. Conley said that is one of the things he wants to discuss with the borough engineer. He said what is before the Council is just a conceptual site plan.

Council President Colucci made a motion to move forward with Scheme 2. Councilman Putrino seconded the motion.

Councilman Cabrera asked for further discussion prior to voting on the motion. He asked for Mr. Conley to elaborate on his concerns with Scheme 3 as it could be done at a significant savings over Scheme 2. Mr. Conley said that we would lose some spaces that are necessary and reducing some spaces to the point where they would require additions in the future to continue to be usable. He said when spending this much money you do not want to design for just today, you want to make sure there is room to grow into.

Councilman Alonso said the goal of building the addition is to make the Police Department more functional and Scheme 3 would not achieve the goal.

Councilman Cabrera asked how many total parking spots are being added. Mr. Conley said this is just conceptual; we will not have the exact configuration of the parking until we get the borough engineer involved. He said he does not want to commit to a number but he can confirm that we would not be losing any parking.

Councilman Cabrera asked if it would be necessary to conduct a traffic study prior to making entrance on Ray Woods Drive two way. Councilman Putrino said the committee has discussed eliminating street parking across from the entrance with Chief Ramaci.

Mayor Subrizi asked for a vote on the motion. The motion carried on a roll call vote as follows:

Prior to casting his vote, Councilman Cabrera asked if Scheme 2 is accepted if there is any opportunity for revision. Mr. Conley said the site plan is conceptual; there will be a new site plan at the end of design development. He said there will also be a capital improvement presentation on the site plan before the Planning Board. Councilman Cabrera said he prefers Scheme 3.

Mr. Conley said he will now get the mechanical, electrical, plumbing and structural engineers involved, in addition to the borough engineer. He said he will also be speaking with material suppliers. This will allow him to nail down the costs and be more specific on what it will look like.

Councilman Cabrera asked if Assessment would be available to the public for the September meeting. Mayor Subrizi said there would be a lot more information available for the September meeting. She said this document is available to the public now.

## 2. New Milford Swim Club

Mayor Subrizi reviewed the discussion with the Risk Manager whereby the Swim Club would be eligible for coverage by the Joint Insurance Fund if identified as a quasi-entity of the Borough. Mayor Subrizi said she and the Risk Manager met with the Swim Club and they confirmed their interest in proceeding. The Mayor noted resolution 2015:224 authorizes sponsorship of the New Milford Swim Club as a Quasi-Entity which will ultimately save them between \$10,000 and \$15,000 at no additional cost to the Borough. She asked for a motion on the resolution. Councilman Putrino made a motion to adopt the resolution. Councilman Cabrera seconded the motion. The motion carried on a roll call vote. All present in favor, none opposed.

## 3. Madison Avenue Bus Stops

Mayor Subrizi said there has been a request from a resident to remove the bus stop on Madison Avenue in front of the VFW. The Mayor said it is the last stop on the NYC route prior to heading back to the Transit garage serving four separate bus routes. The resident claims the stop does not have enough use to support it. Mayor Subrizi said NJ Transit has provided information that as many as 145 people are using the stop on a given day. The Administrator said the original report said 100 but as of July 21<sup>st</sup> it was 145. The Mayor noted the stop for the bus going eastbound is adjacent to New Milford Liquors. She said they generally try to avoid placing stops directly in front of people's homes. The Mayor said she, Councilman Cabrera and the Administrator had a conference call with a representative from NJ Transit. She said she asked if the count is measured by hand or electronically and it was confirmed that it is done electronically. Mayor Subrizi said the municipality has the discretion to remove a bus stop but has no control over the route. She said she would like to take a vote on whether to keep or eliminate the stop.

Councilman Alonso asked if the resident is disputing the number. The Mayor said he disputes the number and believes it is an underutilized stop. Councilman Alonso asked if it is not busy why it is an issue. Councilman Cabrera said the resident's main concern is traffic flow, idling, and soot.

Council President Colucci said it would inconvenience a number of people if the stop is eliminated. He offered a motion to not eliminate the stop. Mr. Madaio said the stop exists by ordinance; unless someone wants to change the existing ordinance a vote is not necessary. He asked if anyone wished to make a motion to amend the existing ordinance to eliminate the bus stop. No member of the Council offered a motion.

4. American Legion Parking Lot

Councilman Putrino said there is a Borough parking lot that sits empty and is not well maintained. He said it is in the same neighborhood as some of the popular Main Street establishments and he suggested making it an official municipal lot to ease some of the traffic/parking burdens in the surrounding neighborhood. He suggested striping the lot and asking Lt. Jones to review the traffic situation with consideration to limiting parking to one side of the street on some of the streets such as Prospect, Demarest and Summit. Mayor Subrizi suggested the engineer should weigh in on the number of spots that can be achieved. All were in agreement to move forward.

5. Gloria Dei – No Parking Sign Request

Councilman Putrino said Gloria Dei Lutheran Church is seeking permission to post “No Parking” signs for unauthorized vehicles in their parking lot. He said the signs would meet the requirements of the sign ordinance and will be submitted to the Police Chief for approval, as per the ordinance, prior to the installation. There was no objection from any member of the Council.

6. CDBG Application

The Administrator said the Community Development application is due in October and she said someone had suggested the idea of a Senior Transportation mini-bus. She said the current van is a 2004, it has approximately 140,000 miles on it and we have made in excess of \$6,000 dollars in repairs over the last few years, which does not include all of the mechanical work that we do in house. She said she has obtained an estimate of approximately \$53,000 for a twelve passenger van and has provided the estimate to the grants consultant who is looking into whether or not this would be fundable through CDBG. She asked if the Council would like to pursue this application. All agreed.

7. Eagle Scout Project Request

The Administrator referenced the information previously provided to the Council about the Knots and Lashing kiosk. Mayor Subrizi asked who would maintain it going forward. Councilman Ashley said the Scout said the troop would. The Administrator asked about the requested location and asked if it would not be better placed near a playground as opposed to next to the gazebo. Councilman Putrino suggested it be placed near the gazebo at Hardcastle Pond. Councilman Ashley said the maintenance at Hardcastle Pond is not up to par. Mayor Subrizi suggested locating it by the playground adjacent to the Little League field. All present agreed. The Administrator will request a more detailed plan with information about maintenance and advise as to the preferred location. The Council agreed to waive the permit fee if any permits are required.

#### 8. Eagle Scout Permit Fee Waiver Request

The Council agreed to waive the permit fee for Scout who is building a kiosk outside the French Cemetery. The Council agreed to waive fees for any Scout requesting it for any approved project. All waivers will be authorized by resolution upon request.

#### 9. Administrator's Report

The Administrator noted that there are currently two meetings scheduled for August when traditionally only one has been held. The Council agreed to cancel the meeting scheduled for August 10<sup>th</sup>. The next meeting will take place on August 24<sup>th</sup>.

The Administrator said the public hearing for the BCOS application for Berkley Field was originally scheduled to take place tonight however it must be advertised at least ten days prior to the hearing. She said she learned of this requirement too late to advertise for a hearing on 7/27. The hearing will be advertised for August 24<sup>th</sup>. She said the estimate for the project is \$135,000 and the grants consultant has advised that we will probably not receive funding for the full fifty percent; the Borough should be prepared to fund fifty percent in addition to any shortfall in the County grant. She said the project could also be modified to reduce the expense noting that the estimate called for sod and seeding could be done for approximately \$30,000 less.

The Administrator said that she planned to add a liquidated damages section to the solid waste bid specification but was advised by the DEP that we are not permitted to do so. The DEP said that all complaints are to be submitted and adjudicated by the DEP. The Administrator said the DPW has been in touch with the DEP but there have been no actionable results.

The Administrator said she has been made aware of some vague complaints regarding our new animal control service and she has been in touch with the vendor to let them know there is some dissatisfaction. The vendor said he was not aware of any issues and said that he is in constant contact with the Health Department. The Administrator asked that any specific complaints be forwarded to her so they can be addressed with the vendor.

The Administrator reported that the Borough received a request by way of a letter to the Mayor to allow the owner of 3 River Edge Avenue in River Edge to connect to New Milford's sewer system. They are currently served by a septic system which is failing. Connection to River Edge's system would involve crossing the railroad crossing and will delay construction. For this reason they have asked to cross the river over the bridge and connect to the New Milford System. As there is absolutely no benefit to New Milford to allow this, and in fact, would only add to our burden with the possibilities of complications, a letter has been sent denying the request.

The Administrator reported on additional liquor license renewals noting a resolution on the current agenda. She said there are two licensees who have yet to complete their renewal but they are still in compliance because the State has extended the deadline to renew to September 18<sup>th</sup>.

The Administrator said she received a request from a production company who has asked to film some generic empty courtroom shots for a true crime show appearing on Investigation Discovery. She asked if there was any objection. There was none.

#### **COUNCIL:**

Councilman Putrino asked about the tobacco ordinance. He said it is worded to reflect the age of 19. Mr. Madaio said that is current state law. Councilman Putrino asked if it could be changed in such a way to reflect state law without specifically listing the age as the age is currently under debate at the state level and may be changed. Mr. Madaio said that it could be reworded in such a way and he would not consider it a substantive change so the public hearing could still take place tonight.

Councilman Putrino said he wanted to confirm that everyone on the Council is on the same page as to what the Borough's expectations are regarding the paving to be done following the PSE&G Energy Strong work. He said our ordinance says they have to pave from curb to curb from all of the cuts and if it is on a street that has been paved within the last five years they would need to pave the entire street. Mayor Subrizi said at the pre-construction meeting they said they would restore all of our roads and meet all the requirements of the ordinance.

Council President Colucci referenced the DOT Pedestrian Safety application for Graphic Boulevard and asked if there was any reason given as to why it was denied. The Administrator said that the only reason ever referenced is the number of applications far exceed the funds available.

Councilman Cabrera suggested we send OEM Swift messages to residents whenever there is an interruption to service such as garbage or recycling. The Council discussed the pros and cons noting the number of disruptions in service and the inability to target specific areas. Councilman Cabrera made a motion to send messages when there is a disruption in service. There was no second to the motion.

Councilman Cabrera said there is a wooden shack in the woods behind West Park Drive. He asked to have it removed. The Administrator will notify the DPW.

Councilman Putrino made a motion to reconvene in Council Chambers. Council President Colucci seconded the motion. The motion carried, all present in favor, none opposed. Time 8:03 PM.

Mayor Subrizi called the meeting to order, asked for a moment of silent prayer and/or reflection, and led the flag salute. Mayor Subrizi read the Open Public Meeting Law and Mission Statements and pointed out the fire exits in the Council Chambers.

## **ADOPT ORDINACE 2015:13**

**AN ORDINANCE AMENDING CHAPTER II OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF NEW MILFORD ESTABLISHING FEES AND PROCEDURES FOR REIMBURSEMENT OF MAYOR'S EXPENSES IN CONNECTION WITH WEDDING AND CIVIL UNION CEREMONIES**

Councilman Ashley made a motion to open to the public for comment on this ordinance. Councilman Putrino seconded the motion. The motion carried, all present in favor, none opposed.

Hedy Grant – 175 Boulevard. Ms. Grant asked if the ordinance is increasing or decreasing the fee. Mayor Subrizi said that it is to decrease the fee.

Councilman Putrino made a motion to close to the public. Council President Colucci seconded the motion. The motion carried; all present in favor, none opposed.

Council President Colucci made a motion to pass this ordinance on the second and final reading. Councilman Ashley seconded the motion. The motion carried on a roll call vote; all present in favor, none opposed.

#### **ADOPT ORDINANCE 2015:14**

AN ORDINANCE TO AMEND BH: CHAPTER XIII OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF NEW MILFORD REGARDING THE PERMITTED AGE TO PURCHASE TOBACCO PRODUCTS

Councilman Putrino asked if the ordinance could be revised to reflect state law rather than to list a specific age. Mr. Madaio said it could be revised and that the revision would not be considered substantive and therefore the ordinance could move forward to the public hearing.

Councilman Ashley made a motion to open to the public for comment on this ordinance. Councilman Putrino seconded the motion. The motion carried; all present in favor, none opposed.

The record reflects that no member of the public wished to comment on this ordinance.

Councilman Ashley made a motion to close to the public. Councilman Cabrera seconded the motion. The motion carried; all present in favor, none opposed.

Council President Colucci made a motion to pass this ordinance on the second and final reading. Councilman Putrino seconded the motion. The motion carried on a roll call vote; all present in favor, none opposed.

#### **ADOPT ORDINANCE 2015:15**

AN ORDINANCE TO AMEND CHAPTER XIX OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF NEW MILFORD ENTITLED "DEDICATION OF LANDS FOR PUBLIC AND RECREATIONAL USES," SECTION 19-2

Councilman Putrino made a motion to open to the public for comment on this ordinance. Council President Colucci seconded the motion. The motion carried; all present in favor, none opposed.

John Bigger – Recreation Director. Mr. Bigger asked for clarification on the area where smoking would be prohibited. He was advised that it will be prohibited upon any public parks and recreation facilities or grounds. He asked if this would include parking lots adjacent to the fields. He was advised that it would.



Councilman Ashley made a motion to close to public. Council President Colucci seconded the motion. The motion carried; all present in favor, none opposed.

Councilman Putrino made a motion to pass this ordinance on the second and final reading. Councilman Ashley seconded the motion. The motion carried on a roll call vote; all present in favor, none opposed.

#### **COUNCIL:**

Councilman Cabrera asked if the Borough could place horses along Madison Avenue to deter buses and cars from stopping and idling in that location. Councilman Alonso asked if we would be permitted to do so on a County road. Mayor Subrizi asked if there would be any liability in doing so. Mr. Madaio said he does not believe the Borough could block the side of a County road and suggested there are lesser means, such as enforcement of the idling laws, to deter vehicles from laying over in the area.

Mayor Subrizi reported she had attended the hearing on the Fresh and Fancy application before the County Agricultural Board on July 20<sup>th</sup> and the hearing was carried to August 26<sup>th</sup>. She said the proposed uses were discussed and the main issue is the parking and the Board asked the two attorneys to meet prior to the 26<sup>th</sup> to propose a solution to the parking dilemma.

Mayor Subrizi said the Planning Board met on July 21<sup>st</sup> at which time the Board discussed the next steps that need to be taken regarding COAH in addition to the revision to the Business Zone ordinance.

Mayor Subrizi said there will be a hearing in Hackensack on August 4<sup>th</sup> at which time the appeal of the Zoning Board's decision on the New Milford Redevelopment application will be decided.

Mayor Subrizi said National Night Out is scheduled for Tuesday, August 4<sup>th</sup>.

Councilman Cabrera said the Green Team, as part of their efforts to attain Sustainable Jersey certification, will be looking into the cost effectiveness of eliminating paper towels in the Borough Hall in favor of hand dryers. He said they will also be looking at switching the lights to motion sensors.

Councilman Cabrera said he will be meeting with the manager that runs the farmer's markets in River Edge and Paramus in the hope of bringing a farmer's market to New Milford.

Councilman Putrino asked about the Fresh and Fancy application and if they have twenty-one chickens on the property. Mayor Subrizi said according to the application they started with twenty-two chicks; she said she does not believe they are yet full grown. Councilman Putrino said chickens are not allowed by ordinance. The Administrator acknowledged they are not but the attorney representing the Borough suggested it may be futile to have them removed when in all likelihood it will be allowed by the Board as it is part of farming; it does not fall under the zoning ordinance.

### **COMMENTS FROM THE PUBLIC**

Councilman Cabrera made a motion to open the meeting for public comment. Councilman Putrino seconded the motion. The motion carried; all present in favor, none opposed.

Gwen Dalton – 459 James. Ms. Dalton expressed concern about the increasing cat population in her neighborhood and asked if anything could be done. She said she called the Health Department

and was referred to Animal Control who said the cats would need to be on Borough property. Mayor Subrizi said there is really nothing that can be done. Ms. Dalton asked if there was an ordinance that requires collared cats to be neutered. She was advised that there is no requirement for them to be neutered, just registered. Mr. Madaio said he would review the ordinances to see if there is anything that may be helpful in addressing the issue.

John Rutledge – River Road. Mr. Rutledge asked if there has been any discussion on making the new Police Department addition energy efficient or solar compatible. Mayor Subrizi said this was part of the discussion in committee and it is also part of the Master Plan. She said it will be part of the design development phase. Mr. Rutledge asked if the cost has been determined. Mayor Subrizi said it will not be firmed up until completion of the design development phase. She said the prices at the outset were \$175 - \$225 per square foot but she is not sure what the current prices are.

Mr. Rutledge commented on a banner posted by a homeowner behind Pancho's claiming the number of rats that have been caught. Mayor Subrizi said there has been significant improvement in the dumpster area at Pancho's.

Hedy Grant – 175 Boulevard. Ms. Grant said she has attended all of the meetings at which Fresh and Fancy has appeared before the Agricultural Board. She said at the third meeting they wanted to have 100 chickens; at the fourth meeting he said they want just thirty or thirty-five. Ms. Grant said the applicant has misrepresented a number of things at these hearings. Ms. Grant said a resident of Stockton Street said the Low family cleaned up the property the day before the April inspection by the County and a day later brought everything back to the property. Ms. Grant said she has learned that you do not need to grow anything to be considered a farm; it is dependent upon a certain percentage of income from agriculture and the agricultural products can be purchased and resold.

Ms. Grant asked for clarification as to what had been approved regarding the Police Department. She asked if the design was more advanced than what was shown to the Council in November. Mr. Madaio said the Council approved Scheme 2 with permission to move to the design development phase.

Thea Sirocchi-Hurley – 455 Ryeside Avenue. Ms. Sirocchi-Hurley asked if the architect will be making a model of the addition. Mayor Subrizi said he is not going to make a 3-D model but there will be a public display of the design. Councilman Putrino said that he asked this of the architect but has not yet gotten a response; there may be a model.

Councilman Putrino made a motion to close to the public. Councilman Cabrera seconded the motion. The motion carried; all present in favor, none opposed.

**July 7 - DPW Negotiation - met with Ray Wiss and DPW attorney. Reduced the amount of issues at odds and we are close to compromise on all issues. Another meeting has to be set up to (hopefully) finalize all points (including salary) which still have to be settled.**

**July 8 - Chief Contract Meeting - We discussed several items. We will now need to meet with the Chief.**

**July 13- Chief Contract Meeting - Met with the Chief to discuss several points of contention that will require compromise. Another meeting has to be set up.**

**July 14 - Zoning Board Meeting - Korean Day Care Center application Part 1 - Next meeting 8/11/15. Several neighbors are concerned with the intensity of use and the parking problems that will result.**

**July 15 - Historic Map dedicated at the Library. The map donated by Marlene Casey is now proudly on display following the restoration, which was funded by the Elks.**

**July 16 - Mediation with RWDSU 108 - a Memorandum of Agreement was reached following 7 hours of mediation. The MOU has been ratified and a final version of the new contract is being drawn up. Of note, is the fact that the two sides never sat together. All negotiations were done through the voice of the mediator.**

**- Police Headquarter Committee - the committee agreed on a plan and will present to the council at the July 27th meeting, with a goal of presenting to the public at the August 24th meeting; voting on accepting it -- and moving forward with a bid.**

**July 20 - Fresh & Fancy Ag Board Hearing (Bergen County 5th floor meeting room) Part 1 - Many residents appeared and the major issue is the parking situation which is negatively affecting the residents with on street parking for the farm customers. Some of the proposed uses, i.e. bees, chicken coops, farm dinners, etc. were also discussed. The Chairwoman asked for the two sides to meet through their attorneys to propose a solution to the parking dilemma. The next meeting is August 26th.**

**July 21 - NM Planning Board - Mr. Grygiel was there to discuss the next steps with COAH. Also on the agenda was a discussion of a proposed business zone ordinance revision. Currently, our ordinance lists the businesses that are prohibited. In order to comport with other towns and better standards, we would like to revise the ordinance to list what is permitted. July 22 - A phone conference was held with NJT regarding VFW bus stop # 12770. Participants were CM Cabrera, Mayor Subrizi, C. Demiris, and NJT rep John DelColle. Following the conversation and the sharing of facts, thoughts, and ideas it was decided that it will be on the agenda (7/26/15) for a vote to keep or eliminate this stop. It is estimated by NJT that 145 riders use this stop, There are four bus routes that are listed on this stop, but most of the riders are noted to be commuting to NYC.



The negotiations committees of the Borough of New Milford and RWDSU Local 108 Public Employees Division agree to the terms of this Memorandum of Agreement, as set forth below.

- The parties acknowledge that these terms and conditions are subject to ratification, and the mediator retains jurisdiction until ratification.
- All parties agree to support and recommend these terms and conditions to their respective constituents for ratification.
- All issues not mentioned herein are withdrawn. All other language in the expired agreement shall continue in the new contract and will remain *status quo*.

**Contract Duration:** January 1, 2015 through December 31, 2017. All relevant sections of the contract will be updated to comport with these dates.

### **Salary Increases:**

- Effective 1/1/15: 2.5% (retroactive)
- Effective 1/1/16: 2.5%
- Effective 1/1/17: 2.5%

### **Article IX Salaries, section C, replace with:**

1. "The Borough retains the right to hire new employees and upon ratification of this agreement the starting rate for full-time positions shall be moved to \$25,000 per annum"
2. ADD to first sentence of IX.C(2): "There is to be a six (6) month probationary period for new full and part time employees, which probationary period may, at the discretion of the Borough, be extended for an additional three (3) month period."
3. Replace IX.C(3) with: Notwithstanding the foregoing, probationary employees shall, after three months receive medical benefits commencing at the start of the fourth month.

### **Article X Workday, Work Week, and Overtime**

ADD to Article X: "An employee who takes a vacation, sick or personal day on Friday, during the Summer Schedule, shall still work from 8:00 a.m. until 4:30



p.m. Monday through Thursday, and will receive up to 2 hours of comp time in lieu of leaving early on Friday."

### **Article XIII Longevity**

Longevity shall not be available to any employee hired on or after December 31, 2011.

### **Article XIX Leave of Absence**

Delete and replace with:

- A. Employer will comply with all applicable State and Federal Laws concerning leaves of absence, including the New Jersey Family Leave Act ("NJFLA") and the Family and Medical Leave Act ("FMLA").
- B. The Governing body, may, at its sole discretion, extend an employee's unpaid leave of absence, beyond that required under applicable law, provided that during any such extension, the employee shall be solely responsible to pay all costs of his or her healthcare coverage.

### **Article XX Medical Coverage/Family Dental/Vision Care Plan**

- A. ADD to last sentence of XX(A): "The Borough shall have the right to obtain, in the place of the foregoing, alternate health care insurance coverage provided that same is substantially similar to the coverage that presently exists."

ADD to XX(A) Employees shall contribute towards the premium payable for the foregoing health care coverage in an amount as required by law, including but not limited to such contributions as are mandated by the provisions of Chapter 78, P.L. 2011 of New Jersey State Law.

- B. Delete current XX(B) and (E).
- I. ADD to current XX(I): The Optical plan shall provide that each employee will be reimbursed for up to \$250 every other year, for the purchase of eyeglasses or contacts.

### **Article XIX Terminal Leave**

For all employees hired after the ratification of this agreement, the following schedule shall apply:

5 years of service or less = 25% of sick bank, maximum 35 days  
6-10 years of service = 35% of sick bank, maximum 75 days  
11-15 days of service = 50 % of sick bank, maximum of 100 days  
16-20 days of service = 60 % of sick bank, maximum of 140 days  
20 or more years = 75% of sick bank, maximum 183 days.

Replace current XIX(A) with: "Sick bank shall be capped at \$20,000. Any employee whose bank was greater than \$20,000 as of December 31, 2011 will be grandfathered at that amount as long as they retain the appropriate number of sick days. 


