7:00 PM PUBLIC MEETING  
Monday, June 22, 2020**



**PUBLIC SESSION:**

Mayor Putrino called the meeting to order, asked for a moment of silent prayer and/or reflection and led the flag salute. Mayor Putrino read the Open Public Meeting Law and Mission Statements. The meeting was held by electronic means in accordance with law.

Councilwoman Duffie made a motion to approve the appointments to the Board of Health. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.

**UNFINISHED BUSINESS:**

Councilwoman Grant made a motion to approve the minutes from the June 8, 2020 Work Session meeting. Council President Grotsky seconded the motion. The motion carried. All present in favor, none opposed.

**NEW BUSINESS:**

1. Schedule Updates – Mayor Putrino

Mayor Putrino reviewed the following list of re-openings:

- Library Curbside Pickup and the Book Drop for returns beginning today. Councilwoman Grant said curbside pickup is by appointment only and for books specifically from the New Milford Public Library
- Williams Field and LaBarbera Field – Maximum occupancy – 25 people – passive recreation; no contact or organized sports
- Recreation Basketball Courts (behind Borough Hall and Prospect Park) – Single, free throw play, one rim per court - Maximum occupancy – 4 people per court

## 2. Assembly Bill 4190

The Administrator said she circulated the information and sample resolution of support for this bill as she thought it may be relevant to the possibility of closing Main Street to vehicular traffic to promote patronage of the restaurants in that area.

Councilwoman Duffie asked if the bill would permit closures indefinitely. Mr. Kelly said that it is a temporary measure in response to COVID-19.

Councilwoman Grant asked if it was a blanket closure or if the Borough could decide the dates. Mr. Kelly said it would be within local control to determine which dates, if any, to close the road.

Council President Grotsky asked about the insurance requirements. Mr. Kelly said the business would have to indemnify the Borough and the County and the insurance information would be reviewed by the Risk Manager and the JIF.

Mr. Kelly said restaurants with temporary ABC expansion of premise permits would need to amend their permit to include the additional area.

Mayor Putrino said he sees it as an opportunity for restaurants to provide additional seating and to potentially free up parking; it would also benefit restaurants without parking lots or sufficient sidewalk space to offer outdoor dining for the day. He said it is possible to close both ends of Main Street at River and the Boulevard, while leaving the middle open to ease traffic and provide access to other businesses in the area.

Councilwoman Grant said the details of dates and location can be decided if the bill passes.

Mayor Putrino said the town can close the street without the passage of this bill; it is a municipal road within the Borough's purview. He said the bill would be of assistance to other municipalities with business located on county roads.

Council President Grotsky said he would support the bill and is in favor of closing Main Street to support the businesses located there.

Councilwoman Grant made a motion to add resolution 2020:171 to the agenda in support of A4190. Councilwoman Sandhusen seconded the motion. The motion carried on a roll call vote. All present in favor, none opposed.

Mr. Kelly said, with the governing body's permission, he would speak to the Risk Manager to draft a proposal that would be acceptable to the JIF.

Councilwoman Duffie asked if businesses in other parts of town would be afforded the opportunity to participate by locating booths or stands on Main Street for the day. Mayor Putrino said he had envisioned it specific to the businesses on Main Street. The Administrator said doing so could create the atmosphere of a street fair, encouraging large groups to gather.

Councilwoman Sandhusen asked if bicycle traffic would be permitted. Mr. Kelly said he would check with the Risk Manager but suggested it may not be safe with food service taking place in the street.

The Council discussed closing Main Street on Sundays with the possibility of July 5<sup>th</sup> as a target date. Mr. Kelly said he will circulate a proposal as soon as he can draft something with the Risk Manager. He said it may require action by the governing body, which would necessitate a special meeting.

### 3. Sutton Street Tennis Courts

The Clerk said one of the projects considered for the Bergen County Open Space grant application was the resurfacing of the Sutton Place Tennis Courts. She said ultimately the decision was made to pursue the application for the team bench covers at the softball fields at Kennedy Field. She said the construction cost for the resurfacing was estimated at \$36,800. She said the Borough currently has \$120,000 in the open space trust account, which replenishes at a rate of approximately \$20,000 per quarter. She asked if there is any interest in fully funding the tennis courts resurfacing project from the open space trust account. If so, she said we would need to appropriate the money by ordinance and authorize the engineer to draft plans and specifications.

Councilwoman Grant asked how long the project would take and when it would be completed. The Administrator said it would take a few months to appropriate the money and get the plans and specifications completed. She said the work itself would probably take just a few weeks. She said if we start the process now, the courts would be completed in the spring.

Councilwoman Grant made a motion to move forward with the project, with funding from the Borough's open space trust account. Councilwoman Duffie seconded the motion. The motion carried. All present in favor, none opposed.

### 4. Administrator's Report

The Administrator referenced information forwarded previously, regarding Vital Check Employee Health screening. She said to provide a safe environment for employees a recommendation has been made to partner with Vital Check to perform an initial health screening and follow-up daily check-ins. She said Vital Check has partnered with doctors from top academic medical centers to provide telehealth services to combat the spread of COVID-19. She said much of the expense is covered by medical insurance. As such, it is a cost-effective way to address concerns of employee health, while eliminating the responsibility to handle and maintain employee health records. She said there is a resolution on the agenda to authorize the Mayor to sign the agreement.

The Administrator reported that plans are underway for Borough Hall employees to return to the office on July 6<sup>th</sup>. She said some work will still be done from home, but offices will be staffed, in person, on a full-time basis. She said the building will not yet be open to the public.

The Administrator said the Primary Election is scheduled for Tuesday, July 7<sup>th</sup>. She said there will only be one polling location, at the VFW on Madison Avenue, as all voters are expected to vote by mail. She said the only in-person voting would be for voters with a disability, who will be permitted to vote in voting machine. All other voters, who show up at the polling location, will be required to vote by provisional ballot.

The Administrator referenced two resolutions forwarded earlier in the day; one to renew the Bergen County Community Development appointments and one to renew the Bergen County Open Space appointment. She asked if anyone would offer a motion to add these resolutions to the consent agenda as resolution 2020:169 and 2020:170.

Council President Grotsky made a motion to add resolution 2020:169 and 2020:170. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.

The Administrator said the next Mayor and Council meeting is scheduled for July 27<sup>th</sup>.

**PUBLIC HEARING:                      BCOS APPLICATION – IMPROVEMENT TO  
SOFTBALL FIELDS AT KENNEDY FIELD**

Councilwoman Grant made a motion to open to the public for comments on this application. Councilwoman Duffie seconded the motion. The motion carried. All present in favor, none opposed.

Frank Feorenzo – 71 Prospect Avenue. Mr. Feorenzo asked if the bench covers were being proposed for all fields. The Administrator said this application is for covers for six team benches at three softball fields at Kennedy Field.

The record reflects that there were no other members of the public who wished to comment on this application.

Councilwoman Duffie made a motion to close to the public. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.

## **COUNCIL**

Councilwoman Grant reminded everyone to complete their Census questionnaire. She said New Milford is ranked fourth out of thirteen municipalities in the 38<sup>th</sup> district with a 76/9% response rate. She said she has ordered Census themed bookmarks, which will be distributed with library books being picked up at curbside.

Councilwoman Sandhusen commended Councilwoman Grant for efforts to promote Census response. She commented specifically on the recent social media campaign that features prominent New Milford residents.

Councilman Seymour said the Recreation Advisory Committee met recently to discuss how and when sports seasons can/will be scheduled pursuant to all of the requirements from the State.

## **COMMENTS FROM THE PUBLIC**

Councilwoman Sandhusen made a motion to open to the public. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.

Frank Feorenzo – 71 Prospect Avenue. Mr. Feorenzo said he supports the idea of closing Main Street to vehicles for a day to help stimulate the businesses in town. He asked about traffic control and parking. He also suggested the use of the municipal lots by Prospect Park and Shop Rite for valet parking. Mayor Putrino said the Police would work with the DPW to make sure the area is marked appropriately to ensure everyone's safety and maintain the traffic flow in the area. He said signs would be posted to direct people to the municipal lots.

Being no other member of the public who wished to comment, Councilwoman Grant made a motion to close to the public. Councilwoman Duffie seconded the motion. The motion carried. All present in favor, none opposed.

## **VOTE ON RESOLUTIONS**

Council President Grotsky made a motion to approve the consent agenda consisting of resolutions 2020:157 through 2020:171. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.

## ADJOURNMENT

Being no further business before the governing body, Councilwoman Duffie made a motion to adjourn. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed. Time 7:59 PM.



**WHEREAS**, Assembly bill 4190 would permit the governing body of a municipality, by resolution, to designate one or more days per week, from Thursday through Sunday, during which any municipal street or road, or county street or road, that traverses a business district of the municipality shall be closed to vehicular traffic and shall be accessible by pedestrians only, so that the owners or operators of restaurants, bars, and retail businesses located on those county or municipal streets or roads may use the streets or roads as an extension of their business premises and conduct retail sales; and

**WHEREAS**, "retail sales" shall include sales of food and alcoholic beverage for consumption at tables owned by restaurants and bars and located for those days on the closed streets, roads, or sidewalks, as determined by the municipality.

**WHEREAS**, this bill is intended to increase economic activity in the State's local business districts, which have been seriously impacted by restrictions imposed to combat the COVID-19 pandemic.

**NOW, THEREFORE BE IT RESOLVED**, that the Mayor and Council of the Borough of New Milford hereby support A4190 and urge the Legislature to enact this legislation quickly.
