UNFINISHED BUSINESS:

Councilwoman Duffie made a motion to approve the minutes from the September 30, 2020 Work/Public Session meeting. Councilwoman Sirocchi-Hurley seconded the motion. The motion carried. All present in favor, none opposed.

ADOPT ORDINANCE 2020:14

AN ORDINANCE TO AMEND CHAPTER II OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF NEW MILFORD ENTITLED "ADMINISTRATION", THEREBY AMENDING SUBSECTION 2-19.1 ENTITLED "COMPOSITION OF THE NEW MILFORD POLICE DEPARTMENT"

Councilwoman Sandhusen made a motion to open the meeting to the public for comments on this ordinance. Councilwoman Sirocchi-Hurley seconded the motion. The motion carried. All present in favor, none opposed.

The record reflects that no member of the public came forward to comment on this ordinance.

Councilwoman Grant made a motion to close to the public. Councilwoman Duffie seconded the motion. The motion carried. All present in favor, none opposed.

Council President Grotsky made a motion to adopt this ordinance on the second and final reading. Councilwoman Grant seconded the motion. The motion carried on a roll call vote. All present in favor, none opposed.

NEW BUSINESS:

1. Borough Property – Block 904 Lots 30 and 31

Mr. Kelly said the Borough received a letter from a property owner in town, who has expressed interest is buying or leasing a piece of Borough property adjacent to his own. Mr. Kelly said the possibility of the sale or lease of this property has been discussed previously and there had been some interest on the part of the governing body. Mr. Kelly said he wanted to find out if there is still interest and if he has the governing body's permission to open a discussion.

Councilwoman Grant asked if the sale or lease of the property would have to be advertised. Mr. Kelly said Title 40A requires it to be auctioned for both lease or sale.

Councilwoman Duffie asked if the Borough leases any property currently. The Administrator said just the ground lease for the cell tower.

Council President Grotsky asked if the sale could be restricted to limit the use of the property as farmland. Mr. Kelly said both a deed or lease agreement can include restrictions.

Councilwoman Sandhusen asked if there are any open space restrictions on the property. Mr. Kelly said it is currently an unrestricted, vacant piece of property.

Councilman Seymour made a motion to authorize Mr. Kelly to speak to the interested party's attorney. Councilwoman Duffie seconded the motion. The motion carried. All present in favor, none opposed. Mr. Kelly said he will find out exactly what is being proposed and will report back to the governing body.

The Mayor also reported that Election Day is November 3rd. He said it is a Vote By Mail election and ballots can be mailed through the USPS, dropped off in one of the eighteen, secure ballot drop boxes located throughout the county, or returned to the polling location on the day of the election. He said in order to return the VBM ballot to the polling location, voters would need to deliver the ballot personally and sign the election book. He said voters who wish to vote at the polls on Election Day can do so by paper, provisional ballot. He said only voters with a verified disability will be permitted to vote in a machine on Election Day.

3. Administrator's Report

- The Covid-19 Task Force met on October 8th. There were reports from the NMPD, NMFD, OEM, Health Department, Administration, DPW, Recreation and the Board of Education. Some of the topics discussed included the extension of outdoor dining permits, Nightmare at the Farm, a Swiftreach message regarding the upcoming election, lights at the basketball and tennis courts, and upcoming events such as the Food Drive, the Drake Drive-By Memorial, the Trick-or-Treat Trail, Veteran's Day and the Holiday Tree Lighting.
- The Administrator referenced a resolution emailed earlier in the day. The resolution establishes the mission, goals and objectives of the Green Team. She asked for a motion to add it to the consent agenda as resolution 2020:226.
 - Councilwoman Sandhusen made a motion to add resolution 2020:226 to the consent agenda. Councilwoman Duffie seconded the motion. The motion carried. All present in favor, none opposed.
- There is a resolution on the agenda to authorize RFQs for the 2021 professional appointments. The RFQ will be posted to the Borough's website by Friday, October 16th.

- The Administration is continuing to work with Seamless Docs to move the Borough's forms and applications to an online platform. There is a significant amount of work that needs to take place on the front end of this process and it is all being done in house so it will take some time to get everything uploaded and get everyone trained.
- The Clerk's office is continuing to work closely with the County in anticipation of Election Day. A Swiftreach call went out on Sunday with information for voters and will be repeated as we get closer to Election Day.
- The next meeting of the Mayor and Council is scheduled for Monday, October 26th

COUNCIL

Councilman Seymour said the panelists for the Domestic Violence Awareness Symposium would be attending in person and participants would be able to attend via a link for Facebook Live. He said he would be creating an email address for anyone who wished to submit a question in advance.

Councilwoman Sandhusen said the Green Team is working hard to have a grant application ready for submission by the October 30th due date.

Councilwoman Grant said the Planning Board approved an application for the Bank of America to upgrade their lighting. She additionally reported on the Supreme Court decision to set the deadline for the collection of census data for midnight on October 15th. She said New Milford has an 82% response, with New Jersey at 69% overall.

Councilwoman Sirocchi-Hurley said there was a great turnout for the food drive this past Sunday and she thanked Boy Scout Troop #78, the DPW, the Police Auxiliary, the Mayor and Council and the residents of New Milford for their participation. Mayor Putrino thanked the residents who came out and donated. Councilwoman Duffie said it was great to see so many people come together for such a worthy cause.

Mayor Putrino said that he attended the Relay for Life Luminaria Ceremony and said that he is hopeful we will be able to host the full Relay for Life event next year.

Councilwoman Grant thanked Councilwoman Duffie and her husband, Joan LePage and the DPW for the fall decorations at the Borough Hall.

Mayor Putrino thanked the DPW for their efforts with street cleaning and said they have done a great job keeping the streets clean after the recent storms.

Councilwoman Sirocchi-Hurley said the Senior Center will be sponsoring Zoom Bingo for seniors on October 20th at 10:30. Councilwoman Grant volunteered to sit in for Mayor Putrino to

call the numbers. Councilwoman Sirocchi-Hurley additionally noted a socially distant photo opportunity for costumed seniors on October 30th at 12:00 noon at Kennedy Field.

Mr. Kelly offered a report, referencing the affordable housing plan the Borough adopted in connection with the settlement of the NMRA lawsuits and in compliance with the Borough's obligations under state law. He said the Borough is obligated to undertake a midpoint review of the plan, which was done in August. He said we are at the midpoint of round three which gives the Borough repose through 2025. He said the review was posted on the Borough website and submitted to the Council on Affordable Housing. He said the settlement agreement, as well as NJ Administrative Code, permits comment on the midpoint review by any interested party. He said the Borough is in receipt of a comment from the Inserra Group and he will be responding accordingly and reporting back to the governing body once he has had sufficient time to review.

Councilwoman Grant asked if the comment is posted on the website. Mr. Kelly said the comment is not on the website and that he does not believe that there is a requirement to do so.

Councilwoman Sandhusen asked to confirm that the midpoint review is posted on the Borough's website. Mr. Kelly said that it is on the Borough's website.

- 6. Members of the public commenting during a remote meeting shall not act in any manner to disrupt the meeting. If such a member of the public becomes disruptive during the meeting, the individual chairing the meeting shall mute, or direct the muting of, the disruptive member and warn that any continued disruption may result in the member being prevented from speaking during the meeting or be removed from the remote meeting. Disruptive conduct includes, but is not limited to, sustained inappropriate behaviors such as shouting, interruption, and the use of profanity.
- 7. Any member who continues to be disruptive after receiving a warning may be muted while other members of the public are allowed to proceed with their comments. If time permits, the disruptive individual shall be allowed to speak after all other members of the public are provided an opportunity to comment. Should the individual remain disruptive, the individual may be muted or kept on mute for the remainder of the remote meeting or removed from the meeting.



WHEREAS, it has become necessary for the Borough of New Milford ("the Borough") to engage legal, financial, and engineering professionals and to engage the services of appraisers for tax assessments as extraordinary unspecifiable services; and

WHEREAS, the Borough desires to appoint such professionals and services by a "fair and open process" pursuant to <u>N.J.S.A</u>. 19:44A-20.1 <u>et seq</u>.

WHEREAS, the Borough of New Milford wants to begin the process of focusing on "GREEN" issues by starting with audits of municipal facilities and operations first; and

WHEREAS, the Mayor and Council will begin the process of making the Borough's operations greener, and more environmentally friendly beginning with energy audits of the town's facilities to pinpoint the most effective ways to reduce energy consumption; and

WHEREAS, solar power, green design, water quality improvements, and operational changes will all be considered as the Borough moves to do their share to lessen the environmental impact of its operations, and

NOW THEREFORE BE IT RESOLVED by the Borough of New Milford that the Mayor and Council hereby establishes the New Milford Green Team consisting of members who shall be residents, nonresidents, or employees of the Borough of New Milford, appointed annually by the Mayor and Council, but whose initial term of appointment shall be through December 31, 2021

BE IT FURTHER RESOLVED, by the Borough of New Milford, that the Mission, Goals and Objectives for the New Milford Green Team through December 31, 2021 are established as follows:

The New Milford Green Team will advise the Borough officials on ways to improve municipal operations with "GREEN" Initiatives which are economically and environmentally sound through research and evaluation.

GOALS

Submit a report and recommendations to the Borough Council by December 31, 2021 to include:

- 1. The Borough of New Milford to be a registered member of Sustainable Jersey by 2021
- 2. To achieve Bronze certification by Sustainable New Jersey through completing actions and achieving Sustainable Jersey points and grant funds.
- 3. Data collection and analysis of municipal assets and energy usage (including building and fleet) to recommend optimal utilization.

OBJECTIVES

- 1. To become Sustainable Jersey certified by completing and documenting required actions.
- 2. To apply for three or more grant applications per year, to support green initiatives in the Borough of New Milford.
- 3. Encourage participation of residents and employees to solicit ideas and implement green initiatives.
- 4. Research and analyze green initiatives which make practical environmental and financial sense.
- 5. Develop plans, implement programs and assist with educational opportunities that support the creation of a more sustainable community.
