Mayor Subrizi called the meeting to order, asked for a moment of silent prayer and/or reflection and led the flag salute. Mayor Subrizi read the Open Public Meeting Law and Mission Statements and pointed out the fire exits.

#### **OPEN SESSION:**

#### 1. Washington Avenue Travel Restriction

The Administrator summarized the email from Lt. Jones in which he said a "no thru traffic" sign may deter travel but would not be enforceable. He additionally addressed the turn lane and said he concurred with the engineer; it is for uniformity with the turning lane into the complex. He further stated his opinion that it would be best to wait until the complex is up and running so an accurate analysis of any traffic issues can be made and addressed.

#### 2. Kennedy Field - Maintenance Policies/Procedures

Mr. Kelly summarized what has taken place and where things stand currently. The field was shut down until such time as it could be confirmed safe. The warranty remains in effect and a GMAX test was performed and the field was reopened when it was confirmed safe. He said he confirmed with the Risk Manager that the insurance coverage was satisfactory and in effect through both the organization and the Borough.

The Council reviewed the draft of the maintenance rules and the Coaches and Players rules and regulations. Council President Putrino said it is a good start but that he has some questions and would like to propose some changes. He said he would like to review it with the Recreation Director, the DPW Director and the Administrator.

Mayor Subrizi said the permit that was pulled for the event should have been by the Meadowlands League and not New Milford Junior Football. The permit application was discussed and the Council agreed there should be modifications to tighten it up.

#### 3. Landscaping Ordinance

Councilman Grotsky referenced the draft ordinance and said it is necessary because the Shade Tree ordinance no longer addresses landscapers. He asked the Administrator to poll other towns to get information on the fees being charged. Council President Putrino asked to also find out if they charge a flat fee or a per vehicle fee. Councilwoman Grant referenced comments she had previously provided by email.

#### 4. Sale of Medical and Recreational Marijuana

Mr. Kelly said he has reviewed both the Senate and Assembly bills and it is clear that any prior municipal action would be deemed void once the law is passed. He said however, the Council could direct him to draft an ordinance to have ready for introduction. He said once the law is adopted the town would have 180 days to enact an ordinance.

Councilwoman Grant said she thinks it is premature to pass an ordinance.

Council President Putrino said he thinks it should be under local control and that New Milford should ban it proactively.

Mayor Subrizi asked for everyone to weigh in on whether or not we should prepare an ordinance in anticipation of the law. Council President Putrino, Councilwoman Langschultz, Councilman Grotsky and Councilwoman Sirocchi-Hurley were all in favor. Councilwoman Grant was opposed. Mr. Kelly was directed to draft the ordinance.

Councilwoman Grant asked if it would be a prohibition on medical, recreational or both. All agreed it would be a ban on the sale of both medical and recreational.

#### 5. Administrator's Report

The Administrator reported that she received the contracts for the Sr. Wellness Nutrition Program today and they need to be signed and returned to the County by 12/28. She asked to add resolution 2018:308, authorizing the Mayor to sign the contract, to the agenda. Councilman Grotsky made a motion to add it to the agenda. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.

The Administrator read a letter from the BOE into the record. In the letter, Superintendent Polizzi said the BOE will not participate in the development of Knights' Field. Mayor Subrizi said this paves the road for the Borough to move forward with the development of the field. Council President Putrino said he will be forming a committee in January.

The Administrator reported that she would be out of the office from 12/24 through 1/2. She additionally noted that Borough offices are closed on 12/24, 12/25, 1/1 and will be closing at 1:00 PM on 12/31.

The Administrator announced the annual reorganization meeting will be held on Monday, January 7, 2019 at 7:00 PM.

#### HAIL AND FAREWELL

Council President Putrino presented Mayor Subrizi with a plaque in recognition of her many years of service to the Borough.

Mayor Subrizi read a brief statement regarding her experience on Council and as Mayor.

#### **PUBLIC HEARING:**

### EXPANSION OF PREMISE – BARREL & BREW PLACE-TO-PLACE TRANSFER

Santo Alampi entered his appearance on behalf of the applicant. Mr. Alampi referenced a drawing by architect Keith Howard Lesser, dated 9/23/18. He said the applicant is before the Mayor and Council to request an expansion of the liquor license. He said the original proposal was for ten tables but it has since been revised to eight. He said he believes the revised plan addresses the questions and concerns raised by the governing body at the last meeting.

Mayor Subrizi said the governing body has received confirmation from the Fire Marshall that he has no objection to the plan as currently proposed.

Councilwoman Grant made a motion to open to the public for comment on the application. Councilwoman Langschultz seconded the motion. The motion carried. All present in favor, none opposed.

Prior to public comment, Mr. Alampi asked to mark the new drawing as A4. Mr. Kelly said A4 is drawing SD1 dated 9/23/18.

Joe Loonam – 469 Marion Avenue. Mr. Loonam said that a similar application for another restaurant was reviewed by the Zoning Board of Adjustment. He was advised that the other restaurant applied prior to the adoption of the outdoor café ordinance.

Being no further comment from the public, Councilwoman Langschultz made a motion to close to the public. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.

Councilwoman Langschultz made a motion to approve the expansion of the licensed premises to include what has been set forth on Exhibit A4, subject to the terms and conditions that were stipulated at the last meeting. Councilwoman Sirocchi-Hurley seconded the motion. The motion carried on a roll call vote. All present in favor, none opposed.

Mr. Kelly said a resolution, memorializing the approval, will be on the next agenda.

#### COMMENTS FROM THE PUBLIC

Councilwoman Langschultz made a motion to open the meeting for public comment. Councilwoman Grant seconded the motion. All present in favor, none opposed.

Joe Loonam – 469 Marion Avenue. Mr. Loonam thanked Mayor Subrizi for her time and dedication. He asked if the previously referenced proposed rules are for all fields or just Kennedy Field. Mr. Kelly said they are for Kennedy Field specifically because of the turf. Noting the use of Green Acres funding for the development of Kennedy Field, Mr. Loonam asked if people from town need to have a permit to use the field. Mr. Kelly said only if they are qualifying as a specific group as identified within the ordinance; he said someone going down for a pick-up game does not need a permit if the field has not been allocated to another group for that time. Mr. Loonam asked if borough employees are subject to drug testing. He was advised that some are dependent upon the position they hold. He asked if the Borough needs to take a position with regard to employees use of marijuana if it is legalized. The Administrator said the Borough abides by DOT rules.

Brian Kuchmack – 186 Cleveland Street. Mr. Kuchmack asked if there has been any additional consideration given to the traffic situation on Cleveland Street and Washington Avenue. He said the intersection is currently unregulated/unmarked and it is approximately 150' off Main Street.

He asked the governing body to do something preemptively or to keep an eye on the intersection after Shop Rite opens.

Paige Ryan – 226 West Street. Ms. Ryan said, as a representative of the BOE, she wanted to acknowledge that the Mayor has always been a partner to the BOE and she thanked her for her service on behalf of herself and the BOE.

Councilman Grotsky made a motion to close to the public. Councilwoman Langschultz seconded the motion. The motion carried. All present in favor, none opposed.

Brandon Spurlin – 383 Hoffman Avenue. Mr. Spurlin asked if taxpayers would be responsible for the debris on field. Councilwoman Langschultz said she was referring to leaves; the comment had nothing to do with the plowing of the field. She said the fill is going to be redistributed by FieldTurf. Mr. Spurlin said he heard there was damage to the field. Mr. Kelly said there was no damage to the field; this has been confirmed by FieldTurf.

Councilman Grotsky made a motion to close to the public. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.
