WORK SESSION:

Mayor Subrizi reads the Open Public Meeting and Mission Statements.

OPEN SESSION:

1. PSE&G Energy Strong Program

The Council reviewed the list of streets to be paved. Councilwoman Grant asked if it covered all the streets that were part of the program. Mr. Cahill said that a few of the streets were pulled from the list because they needed additional work, the money from these streets was allocated to others. Mayor Subrizi said Mr. Cahill rode each and every street with the Borough Engineer and a representative from PSE&G to determine how the money could best be allocated to get the most benefit. Mayor Subrizi asked when the work would begin if the list is approved tonight. Mr. Cahill said they would begin Wednesday, May 11th with the intention to finish everything by the end of June.

The Council agreed to approve the list. It will be memorialized by resolution 2016:148.

2. Solid Waste Contract

The Administrator said that she and Mr. Cahill have discussed the possibility of taking the garbage collection in house and agree that it would be in the Borough's best interest to continue in the current contract by exercising the second option year. She said it is a shared service with the Borough of River Edge and River Edge has indicated that they may opt to go out to bid. She said the contracted rate is very favorable and for this reason she does not recommend putting the contract out to bid. She said if River Edge does decide to put the contract out to bid, Mr. Madaio will ask the contractor to honor the contract price for New Milford individually.

3. DPW – Take Home Vehicle – Assistant Superintendent

Mayor Subrizi referenced the memo from Mr. Cahill. She said the vehicle in question is the older Ford Explorer the Assistant Superintendent uses on a daily basis. Mr. Cahill said he relies on the Assistant Super to respond to emergencies and having the vehicle at home would save time as there is equipment in the vehicle, which would enable him to go directly to the scene.

The Council had no objection to the request to allow the Assistant Superintendent to take home the vehicle he uses on a daily basis.

4. Sanzari's – Barbeque Fund Raiser

The Administrator said this is the same request that comes in annually, however there will be just one date this year as opposed to two. She said it is scheduled for July 19th with a rain date of July 20th.

The Council had no objection. The approval will be memorialized by resolution 2016:147.

5. Liquor License Fees

The Administrator explained that the current ordinance only specifies the liquor license fees through 2015. She said in the absence of another ordinance the fees would remain the same for 2016 but noted the ordinance should be updated to provide clear direction on the fees. She said the fees can be increased by 20% each year and noted the Retail Consumption License and Club License fees are almost at the maximum allowed; the Retail Distribution License is not. The Council agreed to maintain the fees from 2015 going forward. The Administrator will draft an ordinance to affirm the fees.

6. Solar Panels

Mr. Madaio said he took the 2012 ordinance and redlined it with the revisions and additions requested by Councilwoman Grant. He said Councilwoman Grant wants to delete the ordinance just adopted in its entirety. The redlined version was emailed to the Council earlier in the day. Councilwoman Grant said she wanted to update it to include new technologies. She said what she is proposing treats all roofs equally with regard to the placement of solar technology. She said she is not sure the Zoning Board would have the jurisdiction to hear this matter as it is not a zoning issue but rather a building concern. She made a motion to adopt the ordinance that is currently being proposed.

Councilman Alonso said he does not think it was properly explained because what has been proposed is the elimination of D. (v) in its entirety. He said the blanket elimination of the entire section is irresponsible because when it was brought to the Council in 2012 it came from the Fire Department in response to safety concerns. He said the legislative intent should be considered, what was the Council trying to accomplish. He said the Council was obviously trying to accomplish land use regulation, which is a zoning issue. He said the ordinance

should not have been codified under building/housing or fire safety, it should have been codified under the zoning ordinance. He said the way it is worded it is tantamount to a D3 conditional use variance. He said this was clearly intended as a zoning ordinance which is why it should go before the zoning board.

Councilwoman Grant said the safety issues are all addressed in the ordinance and would apply to front facing as well as rear facing panels.

Councilman Alonso said Councilwoman Grant seconded the motion in 2012 to approve the language that is included in the original ordinance. He said he would not feel comfortable eliminating the language in that section without further discussion as to the reasons it was included at the outset.

Councilwoman Grant said she does not recall the discussion about the difference between the front roof and the rear roof but her position has evolved as has the technology. She said she sees absolutely no distinction between front roofs and rear roofs when it comes to installing solar technology.

Mayor Subrizi said the ordinance was constructed at the behest of the Fire Department to be sure safety concerns would be addressed. She said updating the definitions is a good idea. She said that removing section v. makes it easier for homeowners to get solar panels. She said to her it does not seem like a zoning ordinance but rather a building department issue and the building department should be the entity to authorize or not authorize. She said she believes there is movement at the state level that would allow the installation on all roofs and said she suggests we get back on track with the state. She said she would like to eliminate the reference to accessory buildings in the second sentence of D. (i) which allows roof mounted systems to be mounted on accessory buildings.

Councilman Alonso said we should also amend the zoning ordinance to say solar panels are permitted as per the restrictions of this section because it cannot be permitted in a zone in this section of the ordinance.

Mr. Madaio suggested the permitted use should be referenced in the zoning ordinance and said in addition to the revision suggested by the Mayor he would also consider prohibiting the use of ground mounted systems as referenced in (xi). The Council all agreed with this suggestion.

Councilwoman Grant asked Mr. Madaio to draft the revision in ordinance form. Councilman Alonso said he thinks it should be discussed further as he feels that the ordinance could be subject to challenge in court.

Mr. Madaio said while this ordinance is clearly not a zoning ordinance it is the only ordinance that allows the use. He said either this ordinance is invalid and they are not allowed anywhere or we can accept that some ordinances are specific to a certain class of things that say whether or not the use is allowed even though it may not be in the zoning ordinance.

Councilman Alonso said he is not opposed to solar panels, but as a legislative body, he wants to be sure the Council drafts an ordinance the right way. Mr. Madaio said his perception of the right way would be to cross reference it in the zoning ordinance, eliminate the references to ground mounted systems and accessory buildings and lift the restriction on which roof it would be permitted.

Councilman Alonso said he would like to have evidence or testimony presented as to the justification for eliminating section D. (v.) because he said if it is a safety issue he would vote against it. Mr. Madaio suggested having the Fire Department liaison request clarification on the safety issues from the Fire Official.

The ordinance will be drafted, as discussed, for introduction on 5/23.

7. Pet Store Ordinance

Mayor Subrizi said there is a pet store ordinance that restricts the sale of puppy/kitten mill pets. She said the ordinance would have little effect in New Milford because pet shops are not a permitted use in the business zone. She said she would like to pass a resolution of support for the bill, S63, which imposes similar restrictions throughout the State and she asked the Clerk to draft the resolution for the next meeting.

8. Approval of April 25, 2016 Closed and Work/Public Session Minutes

Councilman Cabrera made a motion to approve the minutes of the April 25, 2016 Closed and Work/Public Session. Councilman Colucci seconded the motion. The motion carried. All present in favor, none opposed.

9. Administrator's Report

The Administrator said she wanted to inform the Council of a proposal from the Boy Scouts to create a haunted house in the basement of the Brookchester Shopping Center. She said they asked to do it under the umbrella of the Borough's insurance. She said she discussed it with the Risk Manager and he advised that without the outright sponsorship by a borough department or committee it would not qualify for coverage under the JIF. He further advised that taking on the additional liability is not in the best interest of the Borough.

The Administrator read from an email from Chief Ramaci regarding the Cinco de Mayo celebration. He said the demeanor of the crowd was calm and cooperative but there were a large number of patrons so barricades were deployed on Prospect Avenue and Main Street. He said he had two officers in on overtime and called a third in two hours early for his shift. She said the Borough incurred \$837 in overtime expenses. Councilman Cabrera asked if we would be billing Pancho's for the overtime. The Administrator said that would be up to the Council. The Council unanimously agreed that the overtime charges should be paid by Pancho's.

Councilman Colucci made motion open to the public for comment on this ordinance. Councilman Cabrera seconded the motion. The motion carried. All present in favor, none opposed.

The record reflects that no member of the public wished to comment on this ordinance.

Council President Robalino made a motion to close to the public. Councilman Cabrera seconded the motion. The motion carried. All present in favor, none opposed.

Councilman Colucci made a motion to adopt this ordinance on the second and final reading. Councilman Alonso seconded the motion. The motion carried on a roll call vote. All present in favor, none opposed.

COUNCIL:

Councilwoman Grant made note of the presentation she made as a member of and on behalf of the Bergen County Historic Preservation Advisory Board to the New Milford Historic Preservation Commission which took place at Church on the Green in Hackensack on May 5th.

Councilman Colucci said the Fire Department is discussing where the ceremonial shovel from the groundbreaking for both firehouses should be permanently located. He had suggested Borough Hall. After some discussion it was noted that there is a Fire Department display at the Library and it was suggested that it be placed there.

Councilwoman Grant said the Library may be getting a display case with relics from the USS Arizona.

Council President Robalino said the Drug Alliance is sponsoring a carnival with the New Milford Elks that will run from Wednesday through Saturday. He said the carnival company would like to start breaking down on Saturday after it closes at 10:00. He asked if the noise ordinance could be suspended to allow for this. It was agreed that the ordinance did not need to be suspended but the Police Department will be notified that they were given permission should there be any complaints.

Mayor Subrizi referenced a flyer she distributed for the Rain Barrel event scheduled for June 8th.

Mayor Subrizi reminded the Council of the eco-cruise scheduled for June 25th at 10:00 AM launching from Carlstadt. She said there are five openings for people from New Milford. Councilwoman Sirocchi-Hurley and Councilman Cabrera said they would like to attend.

Mayor Subrizi said the Police Department promotion committee has met and interviews for Captain have been scheduled. She said she expects to have a resolution for the Council's consideration on May 23rd. She said there will also be a resolution to promote Detective Van Sadlers to the rank of Detective Sergeant on May 23rd. She said Detective Van Sadlers has been running the Detective Bureau during Detective Lt. Long's absence. She said Det. Van Sadlers is the only person eligible to be promoted to the rank of Det. Sgt. and therefore a test is not required. She said she would like a vote on the resolution on 5/23 because there is a Sergeant's test on June 3rd and Det. Van Sadlers will not sit for the test if the promotion to Det. Sgt. is approved. The promotion would be effective July 1st.

Mayor Subrizi said she had recently spoken with the Superintendent of Schools who had advised that they are looking to bring in outside acts during the summer and on weekends to the New Milford High School theatre. As part of the plan they would like to work with an outside vendor to serve drinks at adult only events.

COMMENTS FROM THE PUBLIC

Councilman Cabrera made a motion to open to the public. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.

Mark Flores – 150 N. Carlton Place. Mr. Flores spoke on the topic of solar panels stating that he was concerned with adding an additional layer of government to the process. He said aesthetics should not be part of the consideration.

As there were no other members of the public wishing to comment, Councilman Alonso made a motion to close to the public. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.




