OPEN SESSION:

1. Social Services Director

The Administrator reported that the Social Services Director, Donna Foxen, has put in her resignation and will be leaving at the end of August. She said she has advertised the position and has interviewed six candidates to date. She said she hopes to have a recommendation for the Council at the next meeting on August 22nd.

2. OEM Communications – Voice over IP

The Administrator referenced an email she had sent to the Council regarding the need for new OEM/Police/Fire/Ambulance Communications equipment. She said the existing tie lines are in disrepair and emergency calls continue to get dropped. She said the current carrier is no longer supporting the copper lines and therefore repairs have been ineffective. She said she and the Mayor met with the OEM Coordinator who provided the proposal which was forwarded in the email. She said she has drafted a capital ordinance for the Council's consideration and noted the expense would be paid from the capital improvement line with no additional debt to be incurred. She said the ordinance is on the agenda for introduction.

3. Senior Transportation Vehicle

The Administrator referenced an email previously sent to the Council regarding the Sr. Transportation car. She explained that the car is no longer worth repairing and that they are usually replaced with police vehicles that have been taken out of service. She has been advised by the Borough mechanic that there are no suitable police vehicles being taken out of service this year; all are in poor condition requiring repeated repairs. She said the Sr. Transportation service has grown and that residents have been turned down for service in recent months. She referenced the vehicle information sent with the email and said she has

included in the capital ordinance an appropriation for an SUV to be used by Sr. Transportation. As previously noted, the ordinance is on for introduction tonight.

4. Grants – BCOS/Community Development

The Administrator reported that the Bergen County Open Space (BCOS) applications have been announced and while formal applications are not due until October a letter of intent must be submitted by August 10th. She said she spoke with the Grants Consultant, Marlene Casey, and Ms. Casey said she believes the maximum grant award would be between \$50,000 and \$55,000 this year. Recreation Director, John Bigger, has suggested the need for two scoreboards, one at Kennedy Field and one at Williams Field. He has also suggested we include the safety netting for the right field line at Williams Field, which was part of a previous application but was not funded when the grant award was cut.

Councilman Alonso asked if this was the County grant that Ms. Casey said could be used to supplement the Green Acres grant for the turf field. The Administrator said she was not sure but this is the only County Open Space grant that she is aware of ever being made available. Councilman Alonso asked the Administrator to confirm with Ms. Casey that this grant could be used toward the turf field.

Councilman Colucci said the small playground near the Little League field could use some rubber mulch.

Mr. Bigger joined the meeting at 7:15 PM. He offered another suggestion for the grant, noting that the bathrooms at the Recreation Building are in very poor condition and need to be renovated.

Noting the lack of available funds in the municipal open space trust account, Mayor Subrizi said the Council must be fully committed to whatever we apply for because the Borough match will come out of the budget, not the open space trust.

Councilwoman Grant said it might be premature to put a scoreboard at Kennedy Field if it may eventually be converted to a turf field. She was advised that the scoreboards could be relocated in necessary.

Councilman Cabrera and Councilwoman Sirocchi-Hurley suggested we should move forward with the application for the scoreboards and safety netting.

Mr. Bigger said the mulch for the playground need not be included as he has just received a delivery of mulch that can be used at the playground.

Councilman Alonso asked if the Council had any interest in using the application to supplement the Green Acres grant for the turf field. There was no indication of support.

Councilman Cabrera made a motion to write the letter of intent to BCOS for the scoreboards at Kennedy and Williams and the safety netting. Councilwoman Sirocchi-Hurley seconded the motion. The motion carried. All present in favor, none opposed.

Regarding Community Development the Administrator said this application was also announced and eligible projects would include anything that would improve ADA compliance or anything within the eligible block group. She said the eligible block group is from River Road to Congress Street between Reichelt and Linden. This would include Berkeley, Faller, Reichelt and Pacific and could be used for sewers sidewalks, catch basins, drainage, and paving.

Mayor Subrizi suggested that Faller Drive is in dire need of repaving. She also noted the possibility of applying for the accessible bathrooms at the Recreation building.

Councilman Colucci said he thinks the application should be for the bathrooms. All were in agreement.

5. Request to Waive Permit Fee

The Administrator referenced the request from the two local Boy Scout troops to waive the building permit fee for their Nightmare on River Road Haunted House. She noted that we have waived permit fees in the past for scout projects. The Council agreed to waive the fee. A resolution authorizing the waiver was added to the agenda as resolution 2016:207.

6. Eagle Scout Project Maintenance

The Council discussed the Eagle Scout knot board that has been vandalized and was installed in an unsafe manner with exposed concrete footings. The need for maintenance of scout projects was discussed. The Council agreed that a letter should be written to the troop leader explaining the need for the maintenance of these projects and to ask specifically about this project. The troop leader will be advised that the knot board needs to be fixed and maintained in a safe manner or taken down. Councilman Colucci suggested that they may want to write to the VFW to see if the board could be transplanted to that location.

7. Administrator's Report

The Administrator acknowledged the shutdown of DOT work that came about as a result of the Governor's Executive Order. She said that the Boulevard Section 7 is a DOT project and that Berkley Street was bid with the Boulevard which resulted in that job being shut down as well. She said the work began as soon as school let out for the summer but only the curb work has been completed to date. Until further notice from the State the work has been discontinued.

The Administrator said bids were received on July 19th for the Police State Renovation. She said the bids are being reviewed by the Borough Attorney and the Architect and that an objection has been received from one of the bidders, which is being reviewed as well.

Mayor Subrizi said the signalization of the traffic light at Boulevard and New Bridge has been an ongoing discussion for a number of years. She said she worked with the County, the Borough Engineer and members of the Jewish community to find a solution, which was

recently implemented and is working as intended. A calendar of dates was provided to the County and the signal has been programmed to provide adequate time to cross without having to activate the signal manually. At the time the solution was proposed, the County agreed to do the work necessary if the Borough would pay for it. She said we just received the invoice from the County in the amount of \$5,442.15. Noting that this was not included in the budget she said it may be necessary to hold off on payment until later in the year when budget transfers can be made.

Councilwoman Grant asked if this amount was just the dates for the balance of the year. Mayor Subrizi said that it covers through the end of 2016 and new dates would have to be programmed for 2017.

Councilman Colucci suggested asking Bergenfield and Teaneck to contribute to the cost. Mayor Subrizi said both towns made it clear from the start of the discussion that they believed that the issue primarily affects residents of New Milford and therefore they did not participate in process.

Councilman Alonso made a motion to go into closed session. Councilwoman Sirocchi-Hurley seconded the motion. The motion carried. All present in favor, none opposed. Time 7:49 PM.

Councilman Colucci made a motion to file Committee Reports with the Borough Clerk to be spread in full upon the minutes. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.

Councilman Alonso asked for an amendment to the June 27, 2016 Public Session minutes noting he made the motion to adopt Ordinance 2016:17. The minutes will be amended accordingly.

Councilman Colucci made a motion to approve the minutes from the June 27, 2016 Closed, Work/Public Sessions as amended. Councilwoman Grant seconded the motion. The motion carried. All present in favor, none opposed.

INTRODUCE ORDINANCE 2016:18

INTRODUCE ORDINANCE 2016:19

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 2-40, FREE PUBLIC LIBRARY, OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF NEW MILFORD

Councilwoman Grant made a motion to introduce this ordinance. Councilman Cabrera seconded the motion. The motion carried on a roll call vote. All present in favor, none opposed.

The ordinance will be advertised and a public hearing will be held on August 22, 2016.

Councilwoman Grant made a statement as to the origin of the ordinance stating that there had been a recent opening and she believed the Mayor made an appointment contrary to the former protocol. She said in voicing this concern it became apparent that the Borough ordinance and the Mayor and Council bylaws were not consistent with State statute.

Mayor Subrizi responded that at the time of the appointment she was of the understanding that it was the Mayor's appointment to make. She said the Council voted to approve the appointment which is in accordance with State statute and this ordinance which will be adopted.

The ordinance will be advertised and a public hearing will be held on August 22, 2016.

2016:207 Waive Building Permit Fee – Boy Scout Troops 291 and 78

The Mayor explained that resolution 2016:207 was added to the agenda following the work session.

Councilwoman Grant asked how resolution 2016:198 would help students in New Milford. Mayor Subrizi said the Fairness Formula would ensure that every student in the State would get an equal amount of money dedicated to them by the State. She said currently New Milford students get far less than they are entitled to and that if passed it would mean a \$2,306 tax savings to each homeowner. Councilwoman Grant asked to have the resolution pulled from the consent agenda for a separate vote.

Councilwoman Sirocchi-Hurley asked about resolution 2016:199. Mayor Subrizi said the Institute for Educational Achievement is being expanded to accommodate 18-21 year old students. She said the Developer's Agreement ensures that everything will be done according to the approvals granted.

COMMENTS FROM THE PUBLIC

Councilwoman Grant made a motion to open the meeting for public comment. Councilman Colucci seconded the motion. The motion carried. All present in favor, none opposed.

Sheryl Elias – Teaneck, NJ. Ms. Elias stated she owns property in New Milford that she is planning to build on and noted a town sewer line runs through the property. Ms. Elias referenced a release she has been asked to sign and asked if this will apply to the approximately twenty-one other properties with town sewer lines on their property. She said she wants to build her home but is reluctant to sign a release when she could potentially be subject to capricious actions in the future.

Edward Kilarjian – 465 River Road. Mr. Kilarjian said he wished to take a roll call vote of the Council as to their votes to remove the bus stops along River Road. He was advised by Mr. Madaio that the vote is a matter of public record. Mr. Kilarjian went on to say that he was physically abused by Lt. Jones on June 30, 2016 when he was escorted out of the Borough Hall. He said he came back to file a complaint and was put in a detention cell and later taken to Bergen Regional for a psych evaluation.

Helene Baer- 360 Luhmann Drive. Ms. Baer said she was appearing on behalf of Robike Noll who attended the meeting to ask for the Council's consideration of an ordinance that was recently adopted in Westwood and other towns. Ms. Noll said she has an interest in animal welfare and she has sent an ordinance to the Mayor for the Council's consideration that has already been adopted by 55 towns. She said the ordinance deals with puppy mills and non-commercial breeders and backs legislation being proposed by Senator Lesniak, S-63. She distributed a copy of the ordinance just adopted by Wyckoff and asked the Council to consider a similar ordinance. Mayor Subrizi asked the Council to review the ordinance in anticipation of it being introduced at the next meeting. She noted that the business zone ordinance has recently been revised and that pet store is not one of the approved uses, but said this would be an added layer of protection if someone were to apply for a variance to locate a pet store in New Milford.

Patricia Boungiorno – 317 Berkshire. Ms. Berkshire said she supports Ms. Noll's efforts and urged the Council to consider the ordinance.

Terrence McMackin – 400 Madison Avenue. Mr. McMackin asked if the PSE&G work is complete. Mayor Subrizi said all but the concrete streets have been completed and noted that work on the substation continues. Mr. McMackin asked for an update on Jay's Car Care. Mayor Subrizi said there has been no progress. Mr. McMackin expressed concern regarding the turf field proposal that had been discussed earlier in the year; he distributed an article published by the EPA about health issues associated with turf. Mayor Subrizi said the issue is in its preliminary stages and all the health and safety issues will be considered if the project progresses.

Mr. Kilarjian approached the Council again and noted he cleans a section of River Road regularly and asked why there are not more public trash cans along River Road.

Ms. Sharon Hilmer – 563 Columbia Street. Ms. Hilmer said there is still an illegal tattoo parlor operating in the house next door to her and said she has still not received a response from the Health Department. Mr. Madaio said the governing body should refrain from commenting on something while charges are still pending in municipal court. He suggested that the Prosecutor's instructions to the witnesses in the case may preclude them from responding to Ms. Hilmer. He suggested the case should be allowed to proceed to conclusion through the court.

Being no further comment from the public, Councilman Alonso made a motion to close to the public. Councilman Colucci seconded the motion. The motion carried. All present in favor, none opposed.

VOTE ON RESOLUTIONS

Councilman Alonso made a motion to approve the consent agenda consisting of resolutions 2016:188 through 2016:197 and 2016:199 through 2016:207. Councilman Colucci seconded the motion. The motion carried. All present in favor, none opposed.

Councilman Colucci made a motion to approve resolution 2016:198. Councilman Alonso seconded the motion. The motion carried on a roll call vote. All present in favor, none opposed.

Councilman Colucci raised a question from Council President Robalino asking if New Milford could be sued for not having two meetings per month in the summer, similar to what had happened in Hackensack. Mr. Madaio said he would look into it but that different forms of government have different requirements.

Councilman Alonso made a motion to return to closed session. Councilman Colucci seconded the motion. The motion carried. All present in favor, none opposed. Time 9:06 PM.

WHEREAS, New Milford Public Schools receive State funding pursuant to the funding formula known as the School Funding Reform Act; and

WHEREAS, the State of New Jersey does not fully fund the program as currently constructed; and

WHEREAS, in order to operate its' local and regional school systems, the Borough of New Milford has had no alternative but to raise supplemental funding through a local school tax based upon real estate owned within the Borough; and

WHEREAS, utilizing real estate taxes to subsidize the school systems places an undue and unfair burden upon owners of property within the Borough, particularly since those same taxpayers are overfunding other school districts by way of allocation of New Jersey State taxes through the School Funding Reform Act; and
