The Chairman discussed a formula that would determine whether or not it was further exacerbating the preexisting non conformity. - 2) There was also a brief discussion on the difference between patios and decks. The Board Secretary believed the Planning Board was still discussing this matter and would try to get more information on it.
- 3) Chairman Schaffenberger questioned about the rules on recusal. The Board Attorney said the way the law was set up on that was it was a matter of conscience but added there were certain rules that were set forth in the ethics law.
