The Mayor said Mr. Doyle has been involved with many issues on behalf of the Borough since the beginning of the year and she is aware of the billing issues and is keeping close track. She also noted that when two attorneys attend on behalf of DeCotiis they are only billing the Borough for one.

Councilman Ashley asked why there is a motion to move away from the previous planner, Kirwan Associates. The Mayor stated that Kirwan is a small firm with just one planner, she noted the other respondent to the RFQ, Kauker & Kauker is just a two person firm. She acknowledged the fees from Burgis were slightly higher but stated her confidence in being able to negotiate a comparable fee. She said she feels there is a need for a larger firm this year, especially in light of the development application recently submitted.

Councilwoman Duffie stated she could not disagree more. She said Burgis is unfamiliar with New Milford, they are more expensive, and they are not responsive. She said Kauker & Kauker has experience in New Milford and is less expensive.

Mayor Subrizi said she disagrees with Councilwoman Duffie; when Kauker was the planner they overcharged for COAH work she believed to be below par. Her preference is not to work with Kauker again.
