
MINUTES BOROUGH OF NEW MILFORD MAYOR AND COUNCIL JANUARY 4, 2010 7:00 PM



Mayor DeBari called the meeting to order, asked for a moment of silent prayer and/or reflection, and led the salute to the flag. Mayor DeBari pointed out the fire exits in the Council Chambers.

Mayor DeBari read the Open Public Meeting and Mission Statements.

Mayor DeBari welcomed the audience and wished everyone a Happy New Year.

OLD BUSINESS:

The Mayor presented Council President DeLucia with a plaque to thank her for her many years of service to the Borough. Council President DeLucia thanked the Mayor and Council and the borough residents.

NEW BUSINESS:

The Borough Clerk announced the receipt of the Certificates of Election for Councilman Keith Bachmann and Councilman Howard Berner.

Councilman Bachman was sworn in by Municipal Judge Joseph Jones.

Councilman Berner was sworn in by NJ attorney Adam Brown.

Mayor DeBari convened the new 2010 Council and Roll Call was conducted.

Councilman Zeilner made a motion to nominate Councilman Putrino for Council President. Councilwoman Duffie seconded the motion.

Councilman Bachmann made a motion to nominate Councilwoman Subrizi for Council President. Councilman Berner seconded the motion.

The Mayor asked for a roll call vote on the motion to nominate Councilman Putrino. The motion passed on a roll call vote as follows:

Mayor DeBari reported the Fire Department held their reorganization on January 1st and the new officers were sworn in as follows:

Chief Terry Lawler, Assistant Chief Ralph Leonardi, Deputy Chief James Tufaro, Capt. Co. #1 Tony Castella, Capt. Co. #2 Jerry Nolan, Lieutenant Co. #1 Dave Stormer, Lieutenant Co. #2 Tom Ryan.

Mayor DeBari announced "All standing committees and special committees are dissolved and all individual appointments are terminated and relieved of their offices and duties, and indeterminate appointments dissolved."

The Mayor asked if the Council would be willing to vote a consent agend for the professional appointments. Councilman Bachmann asked for a separate vote on the appointmens for Auditor, Planner, and Risk Manager.

Councilwoman Subrizi asked why Councilwoman Duffie was named as the liaison to the Library Board rather than Councilman Berner. The Mayor responded, Councilwoman Duffie asked to be made the liaison to the Library Board.

Councilman Zeilner made a motion to accept the appointments of Borough Attorney through Public Defender. Council President Putrino seconded the motion. All present in favor, none opposed.

BOROUGH AUDITOR 1 Yr. Steven Wielkotz of FWC&C

Councilman Zeilner made a motion to accept the appointment of Steven Wielkotz as Borough Auditor. Council President Putrino seconded the motion.

The Mayor asked if anyone wished to discuss the appointment.

Councilman Zeilner stated that during his past five years on the Council he has had the opportunity to work with Mr. Wielkotz and finds him to be very professional and knowledgeable of the borough's finances. He stated that Mr. Wielkotz has worked well with the CFO and was very responsive to all of the questions from the Finance Committee. He acknowledged additional fees charged to the Borough over the course of the year but stated the fees were for things that needed to be done for the Borough that were voted upon unanimously by the Council. He concluded saying, given the current economic conditions, he did not think it would be a good time to change from someone who has a history with the Borough's finances.

Councilman Bachmann stated he believed the budget Mr. Wielkotz helped the Mayor and Council prepare reflected a \$35,000 or \$37,000 fee. He stated, Mr. Wielkotz knew when the Borough's bonds would come due and what would have to be done in the upcoming year but as of the end of September it was reported he had \$79,000 in fees. Councilman Bachmann stated that if he did something in his home and the contractor charged two and a half times the price quoted he would not hire the contractor again.

Councilwoman Subrizi referenced the fee summary, noting it covered only the period from January 26th through September 28th, and stated it contained only two billings for the 2008 audit, noting her expectation of additional outstanding billing. She agreed Mr. Wielkotz worked well with the Finance Committee but commented that perhaps every time he did help the Borough was charged. Councilwoman Subrizi, wishing to be fair, added there was a \$22,000 charge for the sale of bonds, which was work in addition to what was originally requested. She suggested the cost of doing business with Mr. Wielkotz may be extrordinary and that it may be to the Borough's benefit to shop around.

Council President Putrino stated as the third member of the Finance Committee, what Mr. Wielkotz quoted for the audit was exactly what was paid for the audit. He said, any additional fees were for the additional services the Council asked him to do and voted for him to do including the \$22,000 bond sale; stating it should be no surprise the bill is higher than \$35,000 for just an audit. He added, if he hired someone to do his lawn for \$200 and they gave him a bill for \$300 he wouldn't pay it, but if he hired someone to do his lawn and then asked him to plant a tree he would pay the additional money for the additional service. He continued, noting each year Mr. Wielkotz provides the Council with a letter outling his fees for all services; he came to a meeting and discussed the bond sale and the Council voted unanimously to proceed; he questioned why anyone would be complaining about it now.

The Mayor stated he compared the fees from 2008 vs. 2009. After eliminating the \$22,000 for the bond sale and the \$1,700 for the cap waiver, the 2009 fees would be \$55,000 which is only a 3.4% increase over the 2008 fees. He stated that Mr. Wielkotz does not make the decision on whether or not to sell the bonds, he comes before the Council, makes a presentation and then the Council decides. He noted he felt it was a good decision because the money the Borough will save in selling the bonds far exceeds the fee charged for the sale.

The Clerk reread the motion from Councilman Zeilner to accept the appointment of Steven Wielkotz as Borough Auditor. It was noted Council President Putrino seconded the motion. The motion passed on a roll call vote as follows:

Councilman Bachmann made a motion to accept the appointments of Prosecutor through Domestic Violence Response Team. Councilwoman Duffie seconded the motion. All present in favor, none opposed.

BOROUGH PLANNER 1 Yr. Kauker & Kauker, LLC

Councilwoman Duffie made a motion to accept the appointment of Kauker & Kauker, LLC as the Borough Planner. Council President Putrino seconded the motion.

The Mayor asked if anyone wished to discuss the appointment.

Councilman Bachmann stated he wasn't in favor of complying with the COAH obligation most of all because the League of Municipalities advised against compliance because they expect the rules will just be changed again. He stated that over his negative vote the

Council voted to pay Mr. Kauker \$25,000 to prepare the application and bring the Borough through this third round of COAH. He noted at the one meeting he missed the Council voted to pay an additional \$15,000 to Mr. Kauker to finish the job. He stated that if you look at it from the perspective that he did not know what it would take to finish the job, he shouldn't have been doing the work. If you look at it from the perspective that extra work had to be done, that should have been part of the contract price. He stated the Borough has paid 60% more than the contract price and he feels we have wasted the money. He noted that he received price quotes from two other planners, both of which advised against moving forward with the third round compliance, who quoted \$17,000 and \$16,000 for the work. He said instead the Council decided to pay Mr. Kauker \$25,000 and then another \$15,000 and stated he does not think this is what the taxpayers elected the Council to do.

Councilman Backmann acknowledged the memo from the Planning Board indicating their confidence in Mr. Kauker but stated the Mayor appointed everyone on the Planning Board and used to serve on it himself. He stated he would like to see a resolution from the taxpayers, noting his confidence that they would not unanimously agree to hire this contractor who billed us 60% more than his contract price. He concluded stating this is why he is opposed to appointing him again.

Councilwoman Duffie stated she does not think it is appropriate to shop around for a Planner who agrees with your stand on COAH. She stated that Mr. Kauker operated under the guidance of the Planning Board and within the Mayor and Council's desire to comply with state law, which has been the guiding force throughout the entire frustrating event. She stated Mr. Kauker has proven his competancy on this issue and his devotion to the taxpayers of this town. She acknowledged it cost more than anticipated, stating COAH is unfathomable in the amount of time and money that has been required. She further stated she does not think it is appropriate to pay another planner to reinvent the wheel when we already have it. She stated it is not for the taxpayers to decide it is for the Mayor and Council to decide; having been voted to the position, it is the Mayor and Council's task to make the appointment.

Councilwoman Subrizi stated that when Assemblywoman Vandervalk came before the Council she stated that the Council on Unfunded Mandates gives the Council the right not to do anything about COAH if the municipality has not collected any fees. She stated her belief that New Milford had not yet collected any fees. Councilwoman Subrizi stated she believes the COAH conversation can end until the town has money to pay the people who are making the plan.

Mayor DeBari read into the record a memo from Angelo DeCarlo, Planning Board Chair; a recommendation for the appointment of the Planner for 2010, noting that Planning Board members voted unanimously to reappoint Michael Kauker of Kauker & Kauker, LLC. The Mayor added that the Mayor and Council also passed a resolution in opposition to COAH; to go on record unanimously that although we needed it to comply with state law, the Council does not believe in COAH as it exists today and would like them to look at revising it.

The Clerk reread the motion from Councilwoman Duffie to accept the appointment of Kauker & Kauker as Borough Planner. It was noted Council President Putrino seconded the motion. The motion passed on a roll call vote as follows:
