Councilman Robalino made a motion to go into closed session, Councilman Colucci seconded the motion. All present in favor, none opposed.

At the conclusion of the closed session Councilwoman Grant made a motion to go into open session. Councilman Robalino seconded the motion. All present in favor, none opposed.

1. Administrator's Report

The Administrator reported on the proposed sewer connection to the BCUA line at Henley Avenue. The Council budgeted \$100,000 in the 2013 capital budget based upon an estimate for the work. The plan was sent to the BCUA for their review and approval and they came back with a request for additional work that will cost an additional \$100,000. After discussing with the Engineer, the Assistant Superintendent and the Sewer Foreman it was agreed that a meeting with the BCUA might be the next best step. The Engineer is in the process of scheduling the meeting.

The Administrator reported the PBA has filed their Request for Submission of a Panel of Arbitrators citing a failure to provide retiree health benefits; the list of potential arbitrators was received by the Borough today for review.

The Administrator reported on a call from Robbie Conley regarding the bid opening for the Fire House renovations. He said the bid opening will need to be pushed back a week and a supplement will need to be issued. The Fire Department provided him with the distributor for the kitchen equipment and the distributor has notified Mr. Conley that he will not be able to supply the equipment. She said the advertisement to notify vendors of the supplement will be published in tomorrow's Record.

The Administrator said she has received nine applications for the PMO position, many of which are not well qualified. She said she has received a few that will result in interviews. The deadline to submit an application is Friday 1/31/14.

2. Budget Committee

Councilman Putrino said the Budget Committee has met with Police and Recreation and he will be meeting later in the week with the Administrator and the Buildings and Grounds Supervisor. He said they will schedule with the Fire Department, the Library and the DPW/Recycling. He said they have drafted a spreadsheet to share with the Council within the next two weeks prior to sending it to the Auditor for him to plug in the numbers and let us know where we are and if additional cuts will be required. The Administrator said the budget must be introduced by the March work session.

3. Waste Management Request

The Administrator referenced the letter, previously provided to the Council, from Waste Management in which they requested authorization to begin pick-ups on the Boulevard and River Road earlier than permitted by ordinance. After discussion, the Council agreed to allow pick-ups to commence at 6:00 AM for River Road and the Boulevard only. The ordinance will be revised for introduction. The Police Department will be advised of the change and the contractors will be permitted to start early prior to the adoption of the ordinance.

Councilman Putrino made a motion to adjourn and reconvene in the Council Chambers. Council President Duffie seconded the motion. All present in favor, none opposed.

AN ORDINANCE TO AMEND CHAPTER XXX OF THE ORDINANCES OF THE BOROUGH OF NEW MILFORD ENTITLED "LAND USE REGULATIONS," THEREBY AMENDING SECTION 30-3.2 ENTITLED "FEES"

Councilwoman Grant made a motion to introduce this ordinance on its first reading. Councilman Colucci second the motion. All present in favor, none opposed.

The ordinance will be advertised and a public hearing will be held on February 24, 2014.

OPEN SESSION: (continued from Work Session)

4. Potential Acquisition – Property Adjacent to Fire Co. #2
Councilman Colucci reviewed the request. Fire Company #2 is land deficient and the adjacent property is irregular with a small parcel that may be available for sale from the owner. The Fire Department is interested in acquiring the property for the placement of an existing storage shed. Councilman Colucci said he has had an initial conversation with the owners of the adjacent property and they said they would be willing to entertain an offer on the small parcel. The Assessor has provided information on the assessed value of the parcel in question. The Council discussed formulating an offer and determining the associated costs. Mr. Leibman suggested going back into closed session at the end of the meeting to continue the discussion. The Council agreed.

5. Public Park Recycle Grant The Administrator referenced a summary provided by the Recycling Coordinator. She said application for the grant would be at no cost to the Borough. The Council unanimously agreed to have the Recycling Coordinator pursue the grant.

Council President Duffie made a motion to open the meeting for public comment. Councilwoman Grant seconded the motion. All present in favor, none opposed.

COMMENTS FROM THE PUBLIC

Nick D'Amelio – 349 Trensch Drive. Mr. D'Amelio referenced his attendance at recent Zoning Board of Adjustment meetings. He asked what power the New Milford Environmental Commission requested an environmental study of the impact of the proposed development on the United Water property and the study has never been done. Councilwoman Grant said this was a recommendation of the Environmental Commission but they do not have the authority to cause a study to be done. Mr. Leibman said the Environmental Commission has the power to make recommendations, it is advisory. Mr. D'Amelio said the Council should come up with an ordinance to protect the Borough's interest with regard to environmental issues, the river, and associated properties. He said the study should be done, at the developer's expense, and the town should hire the people to do the work.

John Rutledge – 335 River Road. Mr. Rutledge praised the work of the DPW and Police Department during the recent storms. He noted the Zoning Board scenario (regarding the United Water property) is coming to a close and asked if anyone had had any additional communication with the developer, or their representatives, since the failed attempt by the Board of Education to come to some form of an agreement. Mr. Leibman said his only contact with Mr. DelVecchio was with regard to the service of the two recent complaints. Mayor Subrizi said she has had no contact with anyone associated with the development. Mr. Rutledge asked when the public would be privy to any subsequent discussions between the developer and the town. Mr. Leibman said he has not even filed answers to the complaints as of yet; it is entirely too early to have any conversation. Mr. Rutledge asked when the public would be informed if the Council were to deem it necessary to discuss another approach. Mr. Leibman said any discussion of negotiation of a resolution to the litigation would be done in closed session but any action would be voted upon in public after being properly vetted.

Donna Tomasini – 411 Charles Street. Ms. Tomasini questioned the repetitive nature of the recent reverse 911 notifications. She also noted that she received the calls on only one of the numbers she used to be called on and asked if anyone else reported any issue. The Administrator explained that each notification gives the option for voice, automated voice from text, email and text. If all of those options were employed there would have been multiple points of contact. She advised Ms. Tomasini to go to the Borough website to the link for the notification to be sure both of her telephone numbers were registered.

Being no further comment from the public Councilman Robalino made a motion to close to the public. Councilman Colucci seconded the motion. All present in favor, none opposed.

Board of Education

Our Mayor and Council Re-org meeting was held on Monday Jan 06, 2014. This date coincided with the Re-org meeting of the BOE so I was unable to attend.

On Jan 20, the BOE was to meet for their Regular meeting but because of the snow and the declaration of State of Emergency by the governor, the meeting was cancelled and moved to tonight, coinciding once again to our Public meeting at the M & C.

Municipal Alliance

Because of the change in management at the VFW, where the middle school was to have their Saint Valentine's dance, the cost for cleaning was increased by 50% and the Drug Alliance determined that it was not cost effective to hold the dance there. The idea of having it at an outside location was considered to bring a greater attendance from the student body. Being that the last dance only brought in some \$40.00; the DA determined that they would operate at a loss if it was held at the VFW and so it was brought back to DEO MS., to be held on Friday the 14th of February.

Certificates were printed to be handed out in the coming weeks for the winners of the poster contest where the theme was the Municipal Drug Alliance, as many confuse the Committee with the DARE program mixing one with the other. Not many students from the elementary school participated, but of those that did, three were chosen from different grade levels as winners.

All necessary signatures were collected and paperwork filled out for this year's annual distribution from the State for DA funding. To be filed in the coming days.

New contacts have been made for this year's carnival, where preparations and scheduling will have to be done early, to secure a date and a vendor; and to be held at the NM Swim Club.

Shade Tree-

- 1) Five year management plan- next year the commission will begin working on the new five year management plan. It is necessary for the borough to have an approved management plan in order to maintain immunity.
- 2) The Shade Tree commission would like to remind the Budget Committee that nearly \$11,000 has been collected from Car accidents in the Borough. That money should be added to the Commissions budget or the arbor account. It is the reason for these fines are in place, to help offset some of the cost of the damage incurred by the violation.
- 3) The Shade Tree Commission is planning an aggressive planting schedule for the foreseeable future in order to repair the damage done in the last three years.

DPW All normal maintenance according to the monthly report has taken place.

BUILDING AND GROUNDS:

Normal cleaning and maintenance as reported in the monthly report.

FIRE DEPARTMENT:

I attended the monthly meeting on Monday January 20 2014. Santa detail was Sunday December 15, 200 toys were distributed to New Milford resident children, who may not have otherwise received anything. There were various sites throughout town in which to drop off toys.

The 31st annual Entwistle memorial was held on Friday 1/17/14 in which I attended.

The bids are scheduled to be opened the first week of February, due to minor clarifications, concerning the renovations of Companies 1&2.

Department is still trying to obtain a list of vacant homes throughout town.

I would like to have board of Ed cooperation in having the grammar school in New Milford participate in Fire Safety week, which is still a mainstay in many districts, but not ours.

Resolution Calling on the Legislature to Make Permanent the 2% Cap on Interest Arbitration Awards

WHEREAS, on December 21, 2010, Governor Christie signed into law reforms to the Arbitration process that took effect January 1, 2011; and

WHEREAS, the reforms capped arbitration awards on economic factors to no more than 2%, provided for random selection of arbitrators, expedited the determination of awards, required the arbitrator to provide a written report detailing the weight accorded to each of the required considerations and expedited the appeal process; and

WHEREAS, these reforms marked a dramatic change to the arbitration process and have helped municipalities to control the never-ending rise in public safety personnel costs; and

WHEREAS, a key element of the reforms, capping arbitration awards on economic factors to no more than 2% of the property tax levy will expire on April 1, 2014; and

WHEREAS, while municipalities are statutorily limited to raise their property tax levy by no more than 2%, with very limited exceptions, failure to extend the 2% cap on interest arbitration awards will force municipalities throughout the State to further reduce or even eliminate crucial services, personnel, and long-overdue infrastructure improvement projects in order to fund an arbitration award; and

WHEREAS, the 2% Interest Arbitration cap has controlled one of the largest municipal expense, public safety salaries, not only through arbitration awards but through contract negotiations; and

WHEREAS, absent further action by the Legislature, any contract that expires on or after April 1, 2014, will be subject to all new procedures and requirements, EXCEPT the 2% awards cap; and
