INTRODUCE ORDINANCE 2019:23

CAPITAL ORDINANCE TO APPROPRIATE THE SUM OF \$332,000 FOR THE IMPROVEMENT OF BOULEVARD (SECTION 9 – FROM RIDGE STREET TO NEW BRIDGE ROAD) IN, BY AND FOR THE BOROUGH OF NEW MILFORD, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM A STATE GRANT AND FROM THE CAPITAL IMPROVEMENT FUND OF THE BOROUGH.
