Mayor Subrizi stated the closed portion of the meeting could be waived providing no Council Members needed to discuss the closed minutes presented for approval. All agreed no discussion was necessary. A motion was made by Councilman Robalino, seconded by Councilwoman Grant to approve the closed minutes of March 10, 2014. The motion passed with all but Council President Duffie and Councilman Putrino voting in favor. Both Council President Duffie and Councilman Putrino abstained from the vote.

OPEN SESSION:

1. DOT Grant Opportunities – Capital Alternatives

Marlene Casey and Al Maiocchi spoke to the Mayor and Council about two grant programs, the first of which is a good fit with an ongoing borough project. The time frame to submit the application is very short. The program is called TAP, Transportation Alternatives Project. It is the successor to the T21 Grant, and is primarily for commercial areas. The Borough has previously pursued streetscapes on River Road and one category of the TAP program fits well into the streetscape plan. Pedestrian walkways and bikeways is another category that may be of interest. The area proposed for the streetscape would complete the section to Henley from the previous end point and from the Borough Hall south to approximately the Post Office. The grant is for a minimum of \$250,000 and no more than a million dollars. She said both north and south could be put on the application with the indication that the south portion is the priority. It was recommended that the project be expanded to include a larger area with the idea that the borough may receive only part of the amount requested, in which case the project can be scaled back. The Council discussed crossing Henley and continuing along past Jersey Boys and the appliance store. The elements of the design are up to the Borough officials and engineer, landscaping items need to be specified. Council President Duffie asked if a new Welcome to New Milford sign

could be incorporated into the plan and was told yes. Benches and historical designations were discussed. Ms. Casey talked about the limitations and complications that go with historical designations. Council President Duffie said the Historic Commission recently appeared before the Planning Board with a historic element for the Master Plan and identified the south side of town being discussed as the New Bridge area. Ms. Casey said the application needs to be completed quickly and would require written letters of support from various community groups, committees, boards and commissions, including the Chamber of Commerce, and Lion's Club. The letters should be forwarded to Ms. Casey by May 1, 2014. Also, accident reports, for the last three years, within the area of the scope of work should be included with the application. A resolution will be prepared for the next meeting to authorize Capital Alternatives to prepare the application.

Ms. Casey told the Mayor and Council about the Safe Route to Schools Program. It is for schools kindergarten through eighth grade. It would include the private schools in the Borough. Safety issues must be stated in the application and the grant money requested must be a minimum of \$250,000. The grant includes traffic calming, warning signals and other preventions. The Borough has gotten past grants used to make school areas safer and Ms. Casey asked if there were additional problems that needed to be addressed. The Mayor and Council said they would check with the Board of Education. Mayor Subrizi talked about needs at Gibbs School, including missing curb cuts, issues along the school path, areas without sidewalks, and traffic problems on the north side of the school. Ms. Casey said she and Mr. Maiocchi would review the area the following day. The deadline for both applications is May 15, 2014.

2. RFQ Results – Grant Writer, Historic Home

One RFQ was received by the Borough Clerk. The applicant's name is David Spatz. The Mayor and Council members received copies of the RFQ and have reviewed it. Since only one RFQ was received, it was suggested to advertise again. Mr. Leibman noted his surprise at Mr. Spatz's aggressive price. He stated Mr. Spatz is a professional planner as well as a grant's writer and he be fully capable. Council President Duffie asked if Boswell Engineering could take on the grant writing project. Mr. Leibman said he is aware that some engineers do prepare grant applications but he does not think that Boswell has done it. A poll was taken around the table, all members with the exception of Council President Duffie agreed to hire Mr. Spatz. A resolution will be included in the Consent Agenda.

3. Proposed NJDEP Blue Acres Acquisitions

The Administrator explained an email from the DEP in which the DEP proposed holding a meeting to discuss topical issues regarding properties along flood zone areas. She said she and the borough engineer went over the DEP letter together and a response was drafted based on that conversation. That draft was forwarded to the Governing Body prior to tonight's meeting. The Administrator went over the response, stating the borough wanted to include as many severe and repetitive lost properties as possible, to keep the properties contiguous, to clear properties adjacent to borough owned land as well as other factors. Various properties were discussed as possible viable properties the borough could obtain fitting the criteria. Referencing a map and legend showing the properties, the Governing Body discussed a number of possible acquisitions.

The Council agreed to issue the response as prepared and to stay with the original list of properties proposed.

4. Micro-surfacing – Joint Bid with Riverside Cooperative

The Administrator said she and the Acting DPW Supervisor attended the last Riverside Co-Op meeting where a representative from Tenaflly spoke about a street Tenaflly micro-surfaced last year. The representative stated the process works best on roads without severe damage. The Mr. Calamari met with a representative from Asphalt Paving Systems (APS) and drafted a list of streets that may be good candidates for micro –surfacing. Based upon the APS state contract price of \$2.15 to \$2.30 per square yard we may not be able to complete all of the streets on the list within the \$20,000 budgeted. APS said there could be economies if the Cooperative went out to bid collectively. The Administrator asked if the Mayor and Council had an interest in going out to bid with Riverside for micro-surfacing and the Governing Body agreed.

5. Recycling Pre-bid Meeting

The Administrator reported that one of the bidders asked, at the pre bid meeting, if the Borough would consider changing the recycling pick up day. She said the calendar costs the Borough approximately \$4,000 to produce and mail. The specification would change to reflect the option. The Administrator asked if the bid would need to be re-advertised due to the change. Mr. Leibman said it would need to be re-advertised. It was agreed to leave the bid as is at this time but reexamine the option for next year.

6. Art in Borough Hall

Councilwoman Grant said she has had a dialog with the Art Center of Northern New Jersey, regarding their interest in displaying a couple of paintings in the Borough Hall. The art would be changed on a rotating basis. The Council agreed to allow the display with the understanding that they would be displayed at the Art Center's risk. The Buildings and Grounds Supervisor will be responsible to hang and rotate the artwork.

7. Administrator's Report

The Administrator reported a cable TV show, Undercover Cousins, will be filming in New Milford. They will coordinate with all the appropriate departments.

There is a new date for a car wash request from Gibb's school due to the original date's conflict with Little League Opening Day. The new request is for May 3rd with a rain date of May 10th. Little League opening day is scheduled for April 26th and the Softball Parade is scheduled for April 12th. The Council had no objection.

The Administrator and Deputy Clerk will be out of the office from March 25th through the 27th for the Annual Clerk's Convention.

The next Mayor and Council meeting will be held on the first Monday of April, the 7th.

INTRODUCTION OF THE 2014 MUNICIPAL BUDGET

INTRODUCTION OF ORDINANCE #2014:05

CALENDAR YEAR 2014 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET
APPROPRIATIONS LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

Councilman Putrino made a motion to introduce this ordinance on the first reading. Councilman Ashley seconded the motion. All present in favor, none opposed.

The ordinance will be advertised and a public hearing will be held on April 28, 2014.

Borough Auditor, Steven Wielkottz presented the 2014 budget for introduction. He explained the appropriations are up 1.19 percent over 2013. The tax levy is up less than 1 percent. The impact is 1.2 tax points and municipal tax increase for the average homeowner assessed at \$321,339 is \$38 for the year. Mr. Wielkottz explained the reasons behind the increase. He said that the CAP Index Rate Ordinance is used to maintain the CAP Bank. This budget is over \$700,000 under the appropriation CAP and over \$600,000 under the mandated 2% tax levy CAP, therefore, the Borough has financial flexibility. Mr. Wielkottz thanked the Budget Committee for their hard work. Following the Auditor's presentation of the 2014 budget, Council acted on Resolution 2014:87.

A motion was made by Councilman Putrino, seconded by Councilman Ashley to approve Resolution 2014:87. The motion passed on a roll call vote. All present in favor, none opposed.

INTRODUCE ORDINANCE 2014:06

BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY, NEW COMMUNICATION AND SIGNAL SYSTEMS EQUIPMENT, NEW INFORMATION TECHNOLOGY EQUIPMENT AND NEW AUTOMOTIVE VEHICLES, INCLUDING ORIGINAL APPARATUS AND EQUIPMENT, IN, BY AND FOR THE BOROUGH OF NEW MILFORD, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$5,464,275 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

Councilman Putrino made a motion to introduce this ordinance on the first reading. Councilman Colucci seconded the motion.

Councilman Ashley asked if language could be added to the ordinance at this point. He was advised that new language could not be added as the ordinance is specific to the individual items outlined. Mayor Subrizi read the description and associated cost for each project the bond ordinance is intended for.

The motion to introduce the ordinance passed on a roll call vote as follows:

Councilman Ashley stated he is voting no because the ordinance is in part funding a new police station with an estimated cost of 4.9 million dollars. He said there was no "Needs Assessment" performed, no competition on the design plan, and the project was based on a decade old memo from the Chief of Police. He said Moonachie is building a new police station/borough hall for 2.1 million dollars.

Council President Duffie said the 4.9 million dollar amount Councilman Ashley referred to is one that she is not comfortable with. She is a member of the committee charged with examining the plans for the new police station. The amount of the new building is not finalized. Tax dollars will not be spent lightly and the committee is taking their work seriously.

Councilman Colucci stated he is on the committee with Council President Duffie. He said the reason why the committee has reconvened is because of the increase in the cost since the original presentation. The committee is looking at ways to cut down the square footage because it is the square footage that is driving up the cost.

Councilwoman Grant said it is her opinion the committee will be able to make the project smaller and reduce the cost. She is looking forward to the committee's recommendation.

Councilman Putrino said that he is not comfortable with the total amount on paper and is looking forward to committee updates.

Mayor Subrizi referred to Councilman Ashley's statement regarding Moonachie's building project. She said she read the article to which he referred and the 2.1 million dollars was the amount Moonachie is receiving from FEMA, which is to be added to funds already designated for the new building.

The ordinance will be advertised and a public hearing will be held on April 28, 2014.

Council President Duffie made a motion to introduce this ordinance on the first reading. Councilwoman Grant seconded the motion. The motion passed on a roll call vote. All present in favor, none opposed.

The ordinance will be advertised and a public hearing will be held on April 28, 2014.

COMMENTS FROM THE PUBLIC

Council President Duffie made a motion to open to the public. Councilman Ashley seconded the motion. All present in favor, none opposed.

Ulises Cabrera, 659 Columbia Street – Mr. Cabrera thanked the Mayor and Council for their service. He said he had missed the Blue Acre conversation at the beginning of the meeting and had some questions. He asked if the original list of homes whose residents requested to be purchased by the Borough through Blue Acres was still active. The Administrator explained the criteria for the eligible properties is set forth by FEMA. If a resident signed the original list, the property must fit the severe and repetitive FEMA criteria in order for the property to still be considered active. Additional criteria such as proximity to Borough owned property will also be considered. Invitations will be sent to homeowners meeting the criteria. Mr. Cabrera asked if there will be money left from the bond ordinance introduced tonight to fence around the shooting range along the Hackensack River. Mayor Subrizi said she will pass Mr. Cabrera's concerns along, although the borough insurance company has done an evaluation of the range and deemed it safe. Mr. Cabrera asked if he and his neighbors could plant willow trees on a recently acquired Borough property on Columbia Street. He was told he would need to make his request to the Shade Tree Commission. Also, Blue Acres mandates what is and is not an allowable use on the properties. Council President Duffie said she was contacted last year by someone from Rutgers in regards to developing water gardens in flood prone areas. She acknowledged interest in the idea at the time but has not heard back.

Councilman Ashley made a motion to close to the public. Councilwoman Grant seconded the motion. All present in favor, none opposed.


Councilman Colucci spoke for the record saying he wants the project covered by grant money and he is not for acquisition without grants.
