WORK SESSION:

Mayor Subrizi read the Open Public Meeting and Mission Statements.

Council President Duffie made a motion to go into closed session. Councilman Colucci seconded the motion. All present in favor, none opposed.

At the conclusion of the closed session, Councilman Robalino made a motion to return to open session. Councilman Putrino seconded the motion. All present in favor, none opposed.

OPEN SESSION:

1. DPW Contract Negotiations

Mayor Subrizi said the contract committee members are in the process of meeting to review contracts prior to discussions with the labor attorney. Councilman Ashley expressed his interest in remaining on the committee although he has been unable to attend earlier meetings. Union representatives for the DPW have expressed an interest in sitting with the labor attorney and committee members to review their contract.

2. Building Department Request - Fee Schedule Amendment

The Deputy Clerk reported on a fee under General Provisions within the Building Department's fee schedule ordinance which was inadvertently dropped during an update of the ordinance. A new ordinance will be introduced at the next Mayor and Council meeting to add the fee of \$50 meant for a construction permit for Gas Fired Appliances to be printed back into the code book.

3. Donation Request – Fire Truck

The Mayor and Council discussed the request from a fire chief of a rural fire department in Alabama. Fire Chief Bolton emailed the borough asking the governing body to consider donating a borough fire engine to their fire company after seeing the vehicle, which was up for auction, was not bid on during the borough's GovDeal.com auction. Chief Bolton wrote the governing body about the lack of funding for equipment in Almeria County and said the fire engine would be a great benefit. Councilman Colucci said the vehicle is antiquated and needs work, therefore has no significant market value. It is doubtful the vehicle could be used any longer in New Jersey due to strict operational guidelines set by the state. It was agreed that it could be donated as long as there is no cost or responsibility to the borough at the time of the exchange.

4. Administrator's Report - ADA Ramps

The Deputy Clerk reported that the county has made an offer to the borough to pave Milford Avenue, River Edge Avenue and Henley Avenue if the borough agrees to construct ADA compliant ramps in advance of the paving. Boswell Engineering met with the county to go over the design estimate. A resolution has been drafted for tonight's meeting if the Mayor and Council agree to authorize the work. The Mayor spoke about curb cuts being a good community development grant application and the significant benefit to the town having the county pave three major streets. A timeline for funding the project and the upfront costs of the curb cuts was discussed. The county will reimburse engineering and construction fees after the ramps are put in. Mayor and Council agreed to add the resolution to the agenda.

Council President Duffie inquired on the progress of the Senior Center renovations and an issue regarding the improper installation of a handicap ramp. The Deputy Clerk concurred that she had heard of a problem with the ramp, that the Administrator had spoken with the project architect and that the ramp would be fixed.

Mayor Subrizi reported that the signalization options for New Bridge Road were being studied by the rabbis of neighboring communities. It was left that they would get back to the Mayor.

Mayor Subrizi stated that the traffic light on the corner of Main Street and River Road is broken and will need to be replaced at the borough's expense. Due to the age of the light, parts to repair it are no longer available. An emergency appropriation will likely be necessary because the cost of a new light could cost anywhere from \$100,000 to \$200,000 dollars*. The new light will need to meet all new code requirements.

* Note: The cost provided to the Mayor at the time of the meeting was incorrect. The cost to replace the traffic light is reported to be approximately \$15,000.

Councilman Colucci brought up a concern on behalf of the Fire Department. At this time, procedure dictates that new applicants cannot be considered members, participate in fire department training or activities until background checks come back from review, which is taking a long period of time. The department would like to allow applicants to become members with the provision that if something negative comes up in the background check, they

could be disqualified. The borough attorney offered to look into the issue and make a recommendation.

Councilman Robalino made a motion to reconvene in Council Chambers. Councilman Putrino seconded the motion. All present in favor, none opposed.

PUBLIC SESSION:

Mayor Subrizi called the meeting to order, asked for a moment of silent prayer and/or reflection, and led the flag salute. Mayor Subrizi read the Open Public Meeting Law and Mission Statements and pointed out the fire exits in the Council Chambers.

Marc Leibman explained to all present that although some people had received correspondence saying there would be a public hearing for Ordinance 2014:13 on this evening's agenda, the public hearing and adoption is now scheduled for July 28, 2014. Due to an error in the publication of the newspaper advertisement of the ordinance's introduction, the date on the correspondence is not correct. Notices have been resent to all legally bound parties.

Mayor Subrizi asked if there were members of the audience present because of the notices sent out and after public affirmation, she opened the meeting up to the topic. In anticipation of public attendance, Paul Grygiel, Borough Planner joined the meeting to answer questions and give an overview of the proposed project. Mayor Subrizi reminded everyone that the questions asked tonight will go on record but the public hearing is set for July 28th, and anyone who wants to go on record at the public hearing will need to return.

Councilman Colucci made a motion to open to the public with regard to the proposed rezoning. Councilwoman Grant seconded the motion. All present in favor, none opposed.

PUBLIC COMMENT:

Andrew Harding - 305 Woodland – Mr. Harding said he is concerned over a lack of transparency. He said this ordinance impacts all of New Milford and asked how many residents were invited through letters to this meeting. Mayor Subrizi explained that all discussions of the proposed R-C zone have been in public and that the meetings, times and agendas, are advertised in many formats for public notification. The topic has been in front of the Planning Board and

Council meetings for over a year. Mr. Harding said he will reserve further comments until the next meeting.

It was suggested the borough planner give an overview of the proposed R-C zone for those present. Mr. Grygiel, stated that this proposed ordinance has been discussed since early 2013 according to his notes. The proposed R-C zone would change the existing residential C zone regulations. The R-C zone would encompass all the garden apartment complexes in New Milford. It is his opinion that the present zoning is outdated, does not reflect good design standards for apartment developments and various issues that could cause problems if the properties were to be redeveloped in the future. The R-C zone would allow, in some cases, more intense development in exchange for public benefits. The proposed zoning changes are the same ones that were proposed previously and then challenged in court. The zoning ordinance provides for better parking regulations, design, open space and is written to protect neighbors surrounding the garden apartment complexes. This new zone is part of a master plan update that was adopted by the Planning Board several months ago.

Nicholas Continolis - 250 Reichelt – Mr. Continolis asked who initiated the proposed change, Brookchester or private homeowners. Mayor Subrizi stated that it began over two years ago, when the Council on Affordable Housing regulations were being addressed due to another application being heard by the borough's Zoning Board of Adjustment. During that time the governing body asked Mr. Brunetti of Brookchester Apartments if he would be interested in helping the borough to meet its affordable housing obligation quota. The Mayor explained the Brookchester Apartments do not count in the COAH quota in their current state because they are pre 1986 construction. Mr. Brunetti met with the governing body and then came up with a conceptual building plan that would meet the needs of the borough and add apartment inventory. Mr. Continolis said he is proud of New Milford and has respect for the governing body, but he questions whether the town and Mr. Brunetti are looking to change the zone to satisfy the affordable housing quota.

Mr. Leibman asked Mr. Grygiel to give a short overview of COAH. Mr. Grygiel stated the New Jersey Council on Affordable Housing, COAH, was originally created to provide the opportunity to have reasonably priced housing available within all municipalities in the state. Over the years COAH has created some unreasonable standards that they have imposed on municipalities. In 2008 COAH assigned each municipality inflexible unit numbers, and now New Milford is looking for ways to comply. The new R-C zone is one option the Borough is looking into. In the case of the proposed new Brookchester project the percentage of units meant to be affordable is unclear because the state has not specified new numbers, but COAH does say ten percent of new development should be affordable at this time.

Kendra Lynch -960 Boulevard - Ms. Lynch asked if the new proposed buildings were going to be higher and more populated. Ms. Lynch was told that some of the buildings will be taller and the new building will be considered luxury low to mid rise. Ms. Lynch asked if the borough was considering buying out homeowners adjacent to the Brookchester property and was told no.

Mr. Leibman said the proposed Brookchester conceptual plans and renderings are available to be viewed at Borough Hall. The taller buildings are located on the interior of the sites and not at the edges of the properties. The plan shows deep setbacks, walking paths, and green space.

Aida Cortez – 251 East Woodland Road – Ms. Cortex asked exactly where the new units are proposed to be built. She was told that the question is beyond the knowledge of the governing body and the topic will be addressed at the July 28th meeting by the property owner.

Councilman Colucci made a motion to close the Rezoning Discussion portion of the meeting. Councilwoman Grant seconded the motion. All present in favor, none opposed.

COUNCIL COMMITTEE REPORTS:

Councilman Colucci made a motion to file Committee Reports with the Borough Clerk to be spread in full upon the minutes. Councilman Putrino seconded the motion. All present in favor, none opposed.

Council President Duffie thanked the President of the Historic Commission, the Library, and the Fire Department for the program they put on June 8, 2014. The program celebrated 200 years of Firefighters in New Milford. Councilman Colucci said a pin from former mayor, George Batterson's collection has been added to the artifact collection. Mayor Batterson was the fire liaison in 1947.

Councilman Colucci reported the county work release program will be providing laborers on June 30th to paint the railings around the perimeter of Borough Hall.

OLD BUSINESS:

Council President Duffie made a motion to approve the minutes of the May 28, 2014 Closed Session, Councilwoman Grant seconded the motion. All those present in favor, none opposed.

Councilwoman Grant made a motion to approve the June 9, 2014 Work and Closed Session, noting a correction to the meeting date on page one in the Closed Session meeting minutes. Councilman Colucci seconded the motion. The motion passed on a roll call vote as follows:

ADOPT ORDINANCE 2014:12

AN ORDINANCE TO AMEND CHAPTER XXIV OF THE ORDINANCES OF THE REVISED GENERAL ORDIANCES OF THE BOROUGH OF NEW MILFORD ENTITLED "RESERVED" THEREBY RENAMING CHAPTER XXIV "SALARIES AND COMPENSATION" TO COMPLY WITH NJSA 52:14ISF, SUBSECTION A, PROVIDING FOR THE DEPOSIT OF NET PAY TO ESTABLISH A NEW SECTION, 24-1 ENTITLED "DIRECT DEPOSIT OF NET PAY AT WRITTEN REQUEST OF INDIVIDUAL EMPLOYEE"

Councilman Putrino made a motion to open to the public for comment on this ordinance. Councilwoman Grant seconded the motion. All present in favor, none opposed.

Being no questions or comments from the public, Council President Duffie made a motion to close to the public for comment. Councilwoman Grant seconded the motion. All present in favor, none opposed.

Councilman Colucci made a motion to pass the ordinance on the second and final reading. Council President Duffie seconded the motion. The motion passed on a roll call vote. All present in favor, none opposed.

Mayor Subrizi announced that the meeting will now continue with the Open Session topics not discussed earlier.

OPEN SESSION:

5. PD Headquarters – Committee Update

Councilman Colucci reported that at the last subcommittee meeting Council President Duffie and Councilwoman Grant presented a revised plan that was never discussed or presented before. The plan was a surprise to the architect appointed to the project, Rob Conley. Mr. Conley sent the committee a letter today which stated he would need to charge the borough to review the new set of plans. Council President Duffie said the letter should have been sent earlier.

The Mayor asked that the letter be read in full and recorded into the minutes of the meeting. Councilman Colucci said that he called Mr. Conley to apologize for the surprise presentation at the subcommittee meeting after fifteen months of his working with the borough, designing a safety compliant new building which incorporated the federal style of the existing borough hall building. He said the plan introduced at the last meeting is a modern style which will not blend with the rest of borough hall and will cost about approximately 30% more than Mr. Conley's plan.

Council President Duffie agreed she sat on both the fire department renovations committee and the present police building committee with Councilman Colucci and that Mr. Conley was the project architect for both. She said Mr. Conley brought a number of options to the table for the firehouses project. She said he brought one concept to the police building project. Councilman Colucci said the reason for the single concept was the committee's designation of a specific area to enter the building, through the courtroom for cost efficiency reasons. Council President Duffie said she asked at many committee meetings for alternative plans to be submitted because it is her opinion that the plan detracts from borough hall and the courtroom. She said because her request for new plans was not granted, she went to an architect and former borough councilman and asked him to draw alternative conceptual plans. The Council President and Councilman Colucci debated over various points and the requested changes asked for to Mr. Conley's plan that were made during committee meetings as well as the additional fee Mr. Conley will charge the borough to review the new conceptual plan.

Mayor Subrizi said she was on the committee for the initial meetings and she remembered a number of different conceptual plans Mr. Connolly presented to the committee. The plan the committee is working with now is a product of many meetings as decided by the committee as the best way to go.

Mayor Subrizi asked Council President Duffie and Councilwoman Grant when they met with former Councilman Gadaleta and if there were other people present at the meeting. Council President Duffie stated they met with Mr. Gadaleta at his home and there were no other people there. Mayor Subrizi said it is her opinion that the meeting was in secret, that it will end up costing the borough's residents additional money and that they owe the borough an apology.

Councilwoman Grant said they met with Mr. Gadaleta because they had questions regarding the project and were seeking guidance and advice on the proper language to formulate some of their questions for Mr. Conley. She said the borough did not ask for proposals to find an architect for this project and therefore did not have the benefit of several proposals to see what conceivably could be done. Also, she stated that architects do not usually charge for changes until after the plan is accepted. Councilwoman Grant said the Council President and she are not happy with the placement of the addition and other points of the project. She does not want the end result to be something they are not proud of and spent a lot of money on. She said it would be better to cut loses at this time and spend the money on a project everyone is happy with and will bring pride to New Milford.

Mayor Subrizi agreed that if she had an architectural question she might ask a friend who is an architect advice on what type of questions she should ask, but not to draw plans, show up at the committee meeting, surprising the project's architect with a new plan in hand. She said as mayor, she can sit de facto on committees and she is exercising her right to sit back on the police building committee. Mayor Subrizi said she feels that she was kicked off the committee as a way to have a majority available to delay the project. Since she will now be sitting on the committee someone will need come off because three plus the mayor equals a quorum which is not permitted in a subcommittee. Mayor Subrizi suggested Councilwoman Grant step down. Councilwoman Grant stated her intention not to step down.

Council President Duffie said she would like to address some points Mayor Subrizi made. She said the issue had nothing to do with hiring a friend; it had to do with asking questions at the subcommittee meetings and not getting answers from the project's architect. She said this is why she asked the opinion of someone with knowledge of architecture and the borough. She said the former councilman is not a public safety architectural expert and the borough needs an expert for this project. She said that it is her opinion that Mr. Conley is not living up to what he promised. She said that she wants to know that five years from now she can be proud of the fact that she did all she could, asked every question and that they did everything they could to make a beautiful law and order complex, predominant and placed out front to show the residents what they paid for.

Councilman Colucci stated that it would cost an additional 1.5 million dollars for her new conceptual plan. Both Council President Duffie and Councilman Colucci agreed both architects' plans are not final and Council President Duffie said she asked if Mr. Conley could pull anything from the new plan and he said he would do what he can. She said that Mr. Conley said there were good ideas on the plan. Councilman Colucci said the additional work should be discussed by Council before granting additional money be spent.

Councilman Robalino stated that in restructuring the subcommittee, Councilman Colucci is knowledgeable and everyone agreed he should sit on the police building committee from the onset of the project and therefore he should remain. He suggested Councilwoman Grant stay and Council President Duffie step down from the subcommittee due to the fact that she feels her questions are not being answered.

Mayor Subrizi said since the beginning of committee meetings, when she was on the committee, she asked many questions and Mr. Conley answered all of them. She said she believes the Council President's questions were answered as well. In the original plan, a specific request was made to the architect to keep the new addition behind the borough hall so as not to interrupt the front lines of borough hall, giving the front of the building an unchanged appearance. The plan done by Mr. Conley meets all the criteria asked for, meets all the safety requirements and all state recommendations. It has been reviewed by the prosecutor, and can be sent to anyone else for review. Starting over at this point will add to the costs and the Mayor stated that a new architect should not have been brought in at this point without the governing body's prior knowledge. Council President Duffie said that it was her intention to gather information for the residents of the town. It is her opinion the current plan is not living up to what was promised.

Mayor Subrizi said that she feels that she was dismissed from the committee in order to allow the ambush of the project's architect with a new plan that will amount to 30 percent more in costs, which is approximately 1.2 million dollars. She said she does not want to go in that direction. Council President Duffie said she does not want the extra cost either and she has been supportive of the project's reduction in square footage from the beginning.

Councilman Colucci asked Council President Duffie if her adviser told her of the extra costs involved in relocating the courthouse to another part of the building and the public safety issues that would need to be addressed if the new architect's plan was used. Council President Duffie said that people tell her that the borough hall is falling apart and is overcrowded but the courtroom is the one beautiful element to the building. She does not want a hole to be cut into the courtroom and cast a shadow over it. A debate on aesthetics and style of both sets of plans ensued.

Mayor Subrizi spoke of the egregious deficiencies the borough has within the present building. Of the most egregious is the fact that at this time prisoners now must be taken through the public area of the town hall building to reach the courtroom. Mr. Conley's plan takes into account the two main things the subcommittee wanted to do at the start of the meetings. It maintains the integrity of the building and provides a way for a prisoner to be led from the jail into the courtroom without going through public domain. A brief conversation of descent ensued regarding alternative options for leading prisoners to the courtroom. Councilwoman Grant said that she agrees a good amount of time has been put into the project by the architect, she feels it is not the quantity of time but the quality of the work that does not add up to each other. She said that she is curious to see other options to consider. Councilman Colucci reminded the Councilwoman that Mr. Conley has done a large amount of public safety work for the state of New Jersey. She agreed with the Councilman that she approved of hiring Mr. Conley but it is not working out in this situation although it did work out for the Fire Department project.

Mayor Subrizi asked how much money was paid to Mr. Conley for the police building plans so far. Council President Duffie asked to have the Administrator get the figures and take a step back to review the original options given by Mr. Conley and the money thus far spent.

Mayor Subrizi said that she feels this is a means of delaying the project and Councilman Colucci said this is demeaning to Mr. Conley. Council President Duffie said Mr. Conley has been given three jobs by New Milford and should agree to do what it takes to keep New Milford happy. Councilman Colucci stated the Council President's approach is spending more of the taxpayer's money and spoke to the details of the new architect's conceptual plan's flat roof and noncompliance in the style of the rest of the building. Councilman Colucci spoke about Mr. Conley's willingness to give alternative plans and Mayor Subrizi asked again to read Mr. Conley's letter sent to Mayor and Council into the minutes.

Ms. Demiris:

As you are aware, a new Committee was formed to review the decisions made by the first Committee on the above referenced project. To date, with the attendance at the additional meetings, as well as preparation time, and changes to the design, John Descano and I have spent about eight hours each additional time on the project. These eight hours total \$2,840.00.

At the last meeting, we were given a new design provided by a different Architect with a significantly different concept on the building. Originally, we were taxed with designing a new Police Station located behind the Borough Hall with a single connection to the Courtroom.

This new Concept is looking for us to redesign the project as an addition to the North end of the existing Borough Hall, including redesigning spaces within the existing building for access to the Courtroom. This may even include a total redesign of the Courtroom. Since there are many unknowns in redesigning the existing building, it is difficult to provide a set fee for the Additional Design Services at this time, but I felt it was prudent to notify you as well as Mayor and Council of the additional cost. I am estimating the cost of review of the other Architects design, the redesign of the entire Concept as well as the additional meetings required could be around Twenty Thousand Dollars (\$20,000.00).

It was my understanding the second committee was formed to try and reduce the cost of the project. My initial reaction from the new design is this will increase the cost of the project. There are open two story spaces, which are normally more expensive to construct and maintain, we were told to include brick on the building, and the construction type appears to be a less economical system.

I have been working with the Borough of New Milford officials for several years on the Fire Stations and now with the Police Station, and I felt it was best for me to explain my initial reaction to this request, prior to moving forward and spending the Borough's money. I will proceed in whichever direction the Borough would like, but at this time, I have placed the project on hold until I receive notice of which direction to proceed.

Councilman Colucci made a motion to proceed with the original final plans as per the previous instructions from the committee for the police department. Councilman Robalino seconded the motion.

Councilman Ashley stated if what the committee produces does not have the majority of Council's approval than we will have wasted all of the money spent on the plan.

Councilman Putrino recommended that Mr. Conley should create a new plan, maybe not totally different but with some changes to give the Council two options, with costs associated to each and then move forward.

Councilman Colucci pointed out that within the letter, Mr. Conley stated additional meetings for a new concept would cost about twenty thousand dollars. He reminded the Council that a 5 to 1 vote was taken to move forward.

Councilman Ashley suggested to put together a list of what the Council wants in a police station and put it out for Request for Proposals. He said the more options that come in, the better off the borough is. Councilman Colucci asked Mr. Leibman if that idea would open the borough up to see legal action by Mr. Conley. Mr. Leibman said he could not say without looking at the contract.

Council President Duffie said the project should wait for the Administrator to present the costs up to date and have the borough attorney look into the contract. Mr. Leibman said Mr. Conley should be asked to give the governing body some new concepts for consideration. He said the project may be too far down the road to advertise for Requests for Professionals. The final plan should be something everyone likes.

Mayor Subrizi said that they will have Mr. Conley show the several plans he originally brought initially again. She said that if his contract does not include analyzing another architect's plans than he has a right to charge extra. Councilman Colucci said that he approves strongly of the plans which included the reduced size and cost.

Mayor Subrizi stated again she will be on the committee moving forward. Answers to questions asked at this meeting will get answered by the Clerk's office and borough attorney. The topic is not to be discussed again unless there is a committee meeting or the July 28th Mayor and Council meeting. All members of the governing body will get a set of Mr. Conley's original conceptual plans. The meeting set for July 15th with the architect and police building subcommittee will be cancelled until after the July 28, 2014 Mayor and Council meeting, the topic will be put on the next agenda and Mr. Conley and Chief Papapietro will be notified of the cancelled meeting.

6. Mayor and Council Health Benefits

Mayor Subrizi stated that Councilman Putrino did a report which was sent to the rest of the governing body this morning. Councilman Putrino said that the report took a long time to put together and fact check the numbers. He said basically his proposal is to eliminate tax payer funded health related benefits for the governing body. This concept has been done in in most other towns, the most recent, he thinks is in Fair Lawn. He said every year it gets harder to cut costs within the budget without cutting services to the residents and taxpayers. His report shows all the costs associated with the current health benefits package and the savings the borough would realize by dropping benefits for elected officials starting in January 2015. Future years are more difficult to project due to unknown factors. If the borough were to have done this this year the savings realized would have been about \$130,000.

Councilman Putrino went through the report page by page, explaining the goal of the action is to reduce the tax burden on New Milford residents and property owners and proposed this could be implemented as of January 2015. He feels this date will give all affected parties time to find alternative healthcare. In the current plan, the Mayor and Council receive a small stipend and are eligible for healthcare benefits. In Councilman Putrino's proposal, health care is eliminated and stipends are raised by small amount.

Councilman Putrino's report shows the costs of coverage for the governing body in various levels of coverage as well as a breakdowns and averages of the HRA, Aetna, and Delta separately and together. He asked the Mayor and Council to study the report, ask him any questions they have and to relist the topic on the next regular meeting agenda.

cCOMMENTS FROM THE PUBLIC

Councilman Robalino made a motion to open to the public. Councilwoman Grant seconded the motion. All present in favor, none opposed.

Donna Tomasini 411 Charles Street – Ms. Tomasini asked the Mayor and Council to consider Councilman Putrino's proposal. She said she is paying health benefits for her family and gave the dollar amounts she pays per month and year.

Lori Barton 399 Roslyn Avenue – Ms. Barton thanked Councilman Putrino for his report. She said she has wanted this topic on the agenda for years and that most other communities have gone this route. She said the borough cannot afford to pay health care for the governing body any longer and she would like to see them get higher stipends. She said she hopes the proposal is taken seriously and that when it comes up for a vote she hopes it will be approved.

Councilman Putrino said that for two years in a row the borough's tax rate has gone up very little and it has been a struggle to keep it that way. This is a good way to do it without cutting services.

Anna Leone 505 Boulevard - Ms. Leone said she applauds Councilman Putrino. She has asked for the topic to be brought up in the past. She stated how much she pays per year for single coverage. She said it is overdue and a necessity.

John Rutledge 335 River Road – Mr. Rutledge said he can see both sides of the Police Department situation. He said he would have like to have seen more options. He acknowledged the Mayor would be taking an active role in the subcommittee meetings again and asked what

her goal is. Mayor Subrizi said she wants to move the process forward and to an end. Mr. Rutledge thanked Councilman Putrino for his report and presentation on healthcare. It was acknowledged that the Mayor does not receive borough paid healthcare. Mr. Rutledge asked that future meetings be toned down.

Celeste Scavetta 635 Mabie – Ms. Scavetta thanked Councilman Putrino for his proposal and asked if another option is to get rid of stipends completely and keep healthcare. Councilman Putrino said that it would not be a significant savings. She said that the governing body works very hard and there are not many benefits for all they do. There are other ways to save money in the borough and she hopes there can be a happy medium. Looking into more shared services and other cost cutting ways to save money may be a way to keep benefits.

Lori Barton 399 Roslyn Avenue - Ms. Barton said that she saw in the newspaper that Bergen County has \$17,000,000 in Open Space Funding available, plus \$100,000,000 in available Green Acres funding with an application deadline of July 31, 2014. She asked if the borough could apply for the grants for the purchase of the United Water property as it is under contract at this time. Mayor Subrizi stated that the municipality has other projects that the money can go towards if the application gets approved. Ms. Barton asked if there is a legal proceeding scheduled for tomorrow in Bergen County involving the borough. Mr. Leibman said that there is a meeting regarding a lawsuit. The meeting is set to discuss a discovery schedule and anyone is invited to attend.

Councilman Robalino made a motion to close to the public. Council Colucci seconded the motion. All present in favor, none opposed.

Year End Report for Year 2013 OEM

2013 was a very quiet year with regard to Emergency Management. There were no major weather events and we escaped any major flooding. There were no major windstorms. It turned out to be a very tough winter, but most of the big events occurred in 2014.

If and when the threat of flooding occurs, I am in touch with the Chief in order to be informed as to the actions that are being set into motion. We have a P & P manual to guide us. In such an event the Chief of Police serves as the incident commander.

The Chief of Police, Frank Papapietro, has typically taken care of our reporting requirements. This year we complied with the NJ Meadowlands paperwork requirement. A copy of that report is on file in the NMPD.

The voluminous FEMA paperwork from past events, especially Hurricane Irene, is in the hands of the Chief.

I continue to apply pressure to the NJDEP to allow for pre-releasing of the Oradell Reservoir to alleviate downstream flooding. I monitor the reservoir levels and associated USGS gauges at all times.

Our Blue Acres program is moving forward under the direction of the Clerk/Administrator's office. The Council has voted to move ahead with further acquisitions if they are funded by the State and if Federal monies available.

I serve in this mandated capacity with no salary. I rely on the Chief of Police to be the point person and to provide me with any day-to-day information on all aspects of New Milford's OEM responsibilities.

There are no regular meetings to report on.

The Commission plans to have a table at National Night Out, as always.

Beautification Committee: The committee completed plantings on the property on the corner of Holland & River Edge Rd, River Rd by the flag pole, and at the Senior center.
