

**ORDINANCE NO. 2022:26**

**AN ORDINANCE TO AMEND CHAPTER VII OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF NEW MILFORD ENTITLED "TRAFFIC," THEREBY AMENDING SUBSECTION 7-3.3 ENTITLED "PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS"; SUBSECTION 7-3.4 ENTITLED "PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS"; AND SUBSECTION 7-6.2 ENTITLED "STOP INTERSECTIONS"**

**WHEREAS**, the members of the Mayor and Council of the Borough of New Milford have been advised that the present ordinance does not adequately address the traffic safety concerns that presently affect the residents of New Milford; and

**WHEREAS**, the matter has been reviewed by the Traffic Officer, Lt. Justin Pisano, and a recommendation has been made to the Mayor and Council; and

**WHEREAS**, the Mayor and Council of the Borough of New Milford wish to amend Chapter VII entitled "Traffic" to address the safety concerns that affect the needs of residents;

**NOW THEREFORE BE IT ORDAINED**, by the Mayor and Council of the Borough of New Milford that Chapter VII, Section 7-3.3, Parking Prohibited at All Times on Certain Streets, is hereby amended as follows:

***Add:***

<i>Name of Street</i>	<i>Side</i>	<i>Location</i>
Hoffman Avenue	North	from the easterly curb line of the Boulevard to the easterly curb line of Birch Avenue.

**BE IT FURTHER ORDAINED** that Chapter VII, Section 7-3.4, Parking Prohibited During Certain Hours on Certain Streets, is hereby amended as follows:

***Add:***

<i>Name of Street</i>	<i>Side</i>	<i>Hours</i>	<i>Location</i>
E. Woodland Road	Both	5:00 a.m. to 7:30 a.m. Mon. thru Fri.	from the easterly curb line of Pacific Street to the westerly curb line of Congress Street
Hoffman Avenue	South	5:00 a.m. to 7:30 a.m. Mon. thru Fri.	from the easterly curb line of the Boulevard to the easterly curb line of Birch Avenue

Hoffman Avenue	South	5:00 a.m. to 7:30 a.m. Mon. thru Fri.	from the westerly curb line of the Boulevard to the easterly curb line of Berkley Street

**BE IT FURTHER ORDAINED** that Chapter VII, Section 7-6.2, Stop Intersections, is hereby amended as follows:

***Add:***

On Jordan Road at the northeast corner intersecting Trench Drive

On Jordan Road at the southwest corner intersecting Lacey Drive

**BE IT FURTHER ORDAINED** that the remainder of this ordinance remains unchanged, and that this amendment shall become effective upon passage and publication in accordance with law.
