

**ORDINANCE NO. 2023:05**

**AN ORDINANCE TO AMEND CHAPTER VII OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF NEW MILFORD ENTITLED "TRAFFIC," THEREBY AMENDING SUBSECTION 7-3.4 ENTITLED "PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS" AND SUBSECTION 7-10.1 ENTITLED "LEFT TURN PROHIBITIONS"**

**WHEREAS**, the members of the Mayor and Council of the Borough of New Milford have been advised that the present ordinance does not adequately address the traffic safety concerns that presently affect the residents of New Milford; and

**WHEREAS**, the matter has been reviewed by the Traffic Officer, Lt. Justin Pisano, and a recommendation has been made to the Mayor and Council; and

**WHEREAS**, the Mayor and Council of the Borough of New Milford wish to amend Chapter VII entitled "Traffic" to address the safety concerns that affect the needs of residents;

**NOW THEREFORE BE IT ORDAINED**, by the Mayor and Council of the Borough of New Milford that Chapter VII, Section 7-3.4, Parking Prohibited During Certain Hours on Certain Streets, is hereby amended as follows:

***Add:***

Cooper Street	North	6:30 a.m. to 10:30 a.m. 2:30 p.m. to 3:30 p.m. Mon. thru Fri. School Days Only	from the easterly curb line of River Road to a point of 113'
Cooper Street	South	6:30 a.m. to 10:30 a.m. 2:30 p.m. to 3:30 p.m. Mon. thru Fri. School Days Only	from the easterly curb line of River Road to a point of 133'

**BE IT FURTHER ORDAINED** that Chapter VII, Section 7-10.1, Left Turn Prohibitions, is hereby amended as follows:

***Add:***

<i>Name of Street</i>	<i>Direction</i>	<i>Turn Prohibited to</i>
Cooper Street	West	River Road – Monday through Friday 7:30 a.m. to 8:30 a.m. & 2:30 p.m. to 3:30 p.m. School Days Only

River Road

South

Cooper Street – Monday through Friday  
7:30 a.m. to 8:30 a.m. & 2:30 p.m. to 3:30 p.m.  
School Days Only

**BE IT FURTHER ORDAINED** that the remainder of this ordinance remains unchanged, and that this amendment shall become effective upon passage and publication in accordance with law.
