Councilman Colucci made a motion to go into closed session. Councilwoman Grant seconded the motion. All present in favor, none opposed.

At the conclusion of the closed session Councilwoman Grant made a motion to return to open session. Council President Duffie seconded the motion. All present in favor, none opposed.

Mayor Subrizi reviewed the open session items and noted they would be discussed in Council Chambers.

Council President Duffie made a motion to reconvene to Council Chambers. Councilman Robalino seconded the motion. All present in favor, none opposed.

PUBLIC SESSION:

Mayor Subrizi called the meeting to order, asked for a moment of silent prayer and/or reflection, and led the flag salute. Mayor Subrizi read the Open Public Meeting Law and Mission Statements and pointed out the fire exits in the Council Chambers.

OPEN SESSION:

1. Planning Board Recommendation – Amendment to Development Regulations

Councilwoman Grant said the recommended amendment defines, redefines, or creates definitions for terms such as building coverage, impervious lot coverage, deck, patio, pavement, and structure.

The Administrator said the ordinance would be prepared for introduction at the meeting scheduled for September 22nd.

2. BCUA Sewer Connection at Henley Avenue Update

Mr. Leibman said there is an ordinance on the agenda to provide additional bonding to conduct some fairly emergent sewer repairs. He said at the last meeting there was a representative from the DPW who indicated there may be a less costly alternative in PVC as opposed to the metal pipe being required by the BCUA. Mr. Leibman said he was attempting to set up a meeting with the BCUA to discuss the alternative but in the meantime he has since spoke to the Engineer. According the Engineer the requirement for metal over PVC is not the big driver of the increased pipe. He said in fact, the Engineer prefers the metal pipe for its strength, not because of the potential vehicular traffic overhead, but rather because it is to connect to a trunk line 78" in diameter. He said the BCUA will not permit a small pipe to come into the larger trunk line; they are requiring that a structure be built around the pipe. This chamber is the primary factor driving the cost. He said he is planning to meet with representatives of the BCUA and the Borough Engineer to discuss but he is not hopeful it will result in a lesser requirement.

3. Grant Opportunities – NJDOT/BCOS

The Administrator reported the DOT Grants have been announced and the deadline for applications is October 14th. She said when last discussed the Council was all in favor of continuing on the Boulevard. She said the Grants Consultant, Marlene Casey, explained the reason why the last application for the Boulevard was denied. Ms. Casey said previously, the DOT scored each of the streets and took the average. They have since changed their scoring

method to now score each street individually and Monmouth did not score well and brought the entire application down. Ms. Casey is confident an application for just the Boulevard will be successful. The Administrator said another street previously considered was Ridge and Ms. Casey has suggested Main as well. Ms. Casey said an application for both the Boulevard and Main would be too large so they would need to be prioritized and she suggests going with an application for Boulevard. Ms. Casey said the Borough could apply for Ridge under the DOT discretionary grant category. The Council agreed to submit a discretionary application for this road.

Councilman Colucci said he had also spoken to Ms. Casey regarding a pedestrian safety grant for the intersection of Graphic Boulevard and Berkley Street. He said she advised it would not interfere with any of the other road projects. Councilman Colucci said in addition to the application we would need a letter of support from the Police Chief and perhaps the Principal of Berkley Street School. Other members of the Council suggested letters of support from parents with children at the school. The Council agreed to pursue this application as well.

The Administrator said applications for Bergen County Open Space Park Redevelopment are being accepted as well. Mayor Subrizi asked if this would apply to the Berkley Street School Field. She was advised that it would but we would need an agreement with the Board of Education in place at the time of application. The Council agreed this would be the priority.

4. Library Board of Trustees – Compensation Ordinance

Councilwoman Grant said there were a number of factual errors in the proposed ordinance. 2014:18. She said the basic problem is the Library is an independent organization; the Library Board of Trustees hires the staff and deals with the compensation issues unto itself. Councilwoman Grant said the only role the Borough has is to create the paychecks as a courtesy to the Library. She said for this reason the Board of Trustees has recommended that the ordinance be withdrawn. It was confirmed the ordinance has been withdrawn from further consideration of the Council.

5. Municipal Court – Open Time Payments

The Administrator referenced the memo from the Court Administrator. The memo detailed seven outstanding time payments owed to the Municipal Court by deceased defendants. The matters have been dismissed on record; the Court Administrator is looking to the Mayor and Council to decide if the outstanding balances should be pursued for collection. The Administrator said the amounts total just over \$3,800. Mr. Leibman said it would be a waste of time. The Council agreed not to pursue the outstanding balances. The Court Administrator will be notified of the decision.

6. Shade Tree/Sidewalk Ordinances – Proposed Revisions

This matter was tabled pending further review by the Shade Tree Commission.

7. Recycling Aftermarket Recommendation

Mayor Subrizi reported she, along with the Recycling Coordinator and several members of the Environmental Commission, toured the Atlantic Coast Fibers facility on August 11th.

The Administrator referenced the email from the Recycling Coordinator in which she detailed numerous issues with other aftermarket recycling vendors. The email closed with a recommendation to continue with Atlantic Coast Fibers (ACF) after the current contract expires in October. The Council agreed with the recommendation of the Recycling Coordinator; ACF will be asked to prepare a new proposal for the Council's approval.

8. Gate at Ambulance Corps Lot

This matter was tabled pending additional information.

9. Police Department Plans – Waive OPRA Exception Privilege

Mr. Leibman referenced a discussion at the last meeting whereby a member of the public asked to see plans. Mr. Leibman said there is a valid OPRA exception and a legitimate security concern. He said it is the governing body's decision as to whether or not they would like to waive the exception to allow access to the plans.

Councilman Colucci said the plans could be made available but not necessarily posted to the Borough website. He asked if it would be appropriate to get the Police Chief's recommendation. Mr. Leibman said that it would not be a bad idea.

Councilman Ashley said it is a huge expense, the plans should be made public.

Councilman Robalino suggested limiting access to New Milford residents only. He was advised if the OPRA exception is waived the plans would be available to anyone who requests them.

Councilwoman Grant said she had no objection to releasing the conceptual plans. Mr. Leibman said the Council can waive the exception for the conceptual plans and then consider the final plans separately. Councilman Ashley said the plans will be available when it is put out to bid; we are just delaying the inevitable.

Mayor Subrizi said she would like to have the Chief weigh in on it prior to making a decision. The matter will be relisted for discussion on September 8th agenda.

10. Benefits/Stipends

Mayor Subrizi read a prepared statement which she forwarded to the Clerk for inclusion in the minutes. She closed by stating the issues of benefits and stipends need to be considered jointly in order to calculate the true savings.

Councilman Colucci said he wished Councilman Putrino was present in order to discuss the proposal he originally presented. He said if the Council is, at some point, going to move forward to raise the stipend, which was what was originally proposed, than he thinks the public has a right to know that now.

Councilwoman Grant said they are two separate issues that can easily be divided. She said to think that there may be some further motion regarding stipends is purely speculative.

Councilman Colucci said the issue of raising the stipend was first raised in an eleven page detailed report presented by Councilman Putrino.

11. Administrator's Report

The Administrator said we were originally planning to receive bids on the Hirschfeld Brook Flood Mitigation Project on August 20th. She said a bidder raised some questions that required an addendum to the bid spec. For this reason the bid opening has been rescheduled to September 3rd.

The Administrator reported the Recycling Coordinator has received interest from the elementary schools to participate more fully in their recycling efforts. Currently the BOE picks up recycling from the two elementary schools and brings it to either the middle school or the high school because there is not enough space to place dumpsters at the elementary schools. This system has been less than successful. Agreeing that there is significant opportunity for improvement, the Recycling Coordinator has agreed to provide cans that can be placed curbside for pick-up. Until this can be incorporated into the bid specification next Spring, the Recycling Coordinator will work with the schools to facilitate pick-up of the cans internally.

The Administrator said she had met with the VFW Commander and she is hopeful we will be able to come to an agreement to allow us to maintain the voting districts 3 and 5 at the VFW.

COUNCIL COMMITTEE REPORTS:

Councilman Colucci made a motion to file Committee Reports with the Borough Clerk to be spread in full upon the minutes. Councilwoman Grant seconded the motion. All present in favor, none opposed.

Councilman Colucci thanked the DPW for replacing one of the Welcome to New Milford signs.

APPOINTMENTS: JACK CLARKE – FIRE CO. #2

Councilman Colucci made a motion to appoint Jack Clarke to Fire Co. #2 and noted he was unable to attend the meeting as he is at fire school. Council President Duffie seconded the motion. All present in favor, none opposed.

OLD BUSINESS:

Council President Duffie made a motion to approve of the minutes from the July 28, 2014 Closed, Work and Public Session. Councilman Colucci seconded the motion. All present in favor, none opposed.

Councilman Robalino referenced the presentation on the utility audit, at the last meeting, by Koteen Associates and asked the status. Mr. Leibman said he believed we were waiting on updated references. The Administrator said we were also waiting on a definitive decision on whether or not we would need to go out to bid for this type of service. Mr. Leibman said he would follow up with his associate. The matter will be relisted on the September 8th agenda.

NEW BUSINESS:**INTRODUCE ORDINANCE 2014:23**

BOND ORDINANCE TO AUTHORIZE THE BYPASS OF THE BOROUGH'S SANITARY SEWER LINE AND CONNECTION TO THE BCUA TRUNK LINE AT HENLEY AVENUE IN, BY AND FOR THE BOROUGH OF NEW MILFORD, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$60,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION, TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS AND TO AMEND BOND ORDINANCE NO. 2010:07 ADOPTED ON APRIL 26, 2010, AS PREVIOUSLY AMENDED BY BOND ORDINANCE NO. 2013:05 ADOPTED ON MAY 13, 2013.

Councilman Ashley made a motion to introduce this ordinance on its first reading. Councilman Robalino seconded the motion. The motion passed on a roll call vote. All present in favor, none opposed.

The ordinance will be advertised and a public hearing will be held on September 22, 2014

COUNCIL:

Councilman Robalino reported that funding was approved through the DOT for the Chestnut and Cherry Street Drainage project. He also commented on the recent installation of a number of pedestrian crossing signs at the crosswalks on the Boulevard.

Councilman Colucci said he contacted the Property Maintenance Officer through the Building Department regarding the recent influx of political signs, many placed in the Borough right-of-way. After discussion, the Council agreed that the PMO should be instructed to remove any and all signs, including political signs, that are placed in the Borough right-of way.

Councilman Ashley commented on a historic map found by Marlene Casey; the New Milford-Teaneck Elks have donated \$2,700 to have the map framed and restored and once completed it will hang in the New Milford Library.

Councilman Colucci reported that a former neighbor had recently donated a bound book of newspapers to the Historic Preservation Commission from the 1908 Hackensack Republican.

Councilwoman Grant stated that August 26th is Woman's Equality Day marking the 94th anniversary of the date that woman were granted the right to vote.

COMMENTS FROM THE PUBLIC

Councilwoman Grant made a motion to open the meeting for public comment. Council President Duffie seconded the motion. All present in favor, none opposed.

Donna Tomasini – 411 Charles Street. Ms. Tomasini asked if the Council would consider holding the open session prior to the closed session at future meetings. Mayor Subrizi said the Council is often considering very important decisions during the closed session and the discussion are not always productive at the end of the evening. Councilman Colucci said on some occasions it is necessary to take action upon the conclusion of the closed session and that must take place during open session. Mayor Subrizi referenced the lengthy agenda and noted the Council meets only once during the months of July and August; she said she plans to suggest two meetings be held in July and August going forward.

Ulises Cabrera – 659 Columbia Street. Mr. Cabrera commented there are no signs on Columbia and Dilworth behind the Dorchester apartment complex to indicate the overnight parking ordinance. He asked the Council to consider placing signs on these streets.

Mr. Cabrera mentioned Dorchester tenants have complained that Shop Rite employees are parking on Dilworth. Mr. Cabrera asked the Council to speak with Shop Rite management. Councilman Colucci said he has spoken with Shop Rite management and he will speak to them again. Mr. Cabrera additionally asked that the Council confirm the apartments are up to code in providing the required amount of handicap parking.

Mr. Cabrera commented on the use of personal information, provided as part of youth sports registration, being used for reasons other than communication about the sport. He specifically referenced a request for a political donation. He asked the Council to pass an ordinance to prohibit the use of the information for any reason other than what it was provided for. Council President Duffie asked if there is a policy. The Council discussed how to implement a policy. Mr. Leibman confirmed it would have to be a policy adopted by the Recreation Commission. The Administrator was instructed to issue a memo to the Recreation Commission to ask them to adopt a policy.

Mr. Cabrera said he was recently granted approval from the Beautification Commission to make memorial parks at the five properties recently acquired by the Borough, whereby residents would donate trees in memory of a loved one. He said he would work with the town arborist to create a

landscape design and then create a list of trees that can be purchased. He asked to confirm the Beautification Committee was still permitted to fundraise. He plans to next bring the idea to the Shade Tree Commission. He was advised that there is a dedicated trust specifically for Beautification Committee donations.

Mr. Cabrera then asked Councilman Robalino to refer to him, Mr. Cabrera, by name. He said he has been made aware that Councilman Robalino has been referring to him, Mr. Cabrera, by terms other than his name in conversation and text messages.

Angelo DeCarlo – 783 Princeton. Mr. DeCarlo said Graphic Boulevard at River Road is a mess with potholes and should be looked at. Regarding parking, Mr. DeCarlo asked if there is an ordinance pertaining parking too close to a corner. Mr. Leibman said State statute prohibits parking within 50' of a stop sign. Mr. DeCarlo asked if there are restrictions if there is no stop sign. He said there is a person, he believes to be an employee of the Woodcrest Center, who parks on the north side Graphic Boulevard at Trenton Street within 10' of the corner. The matter will be referred to the traffic officer.

Mr. DeCarlo also commented on the passing of Mr. Robert Leonard and his service to the town.

Terrence McMackin – Madison Avenue. Mr. McMackin referenced a comment made earlier about speeding on Graphic Boulevard. He said he has been asking for years to have radar on Madison Avenue. Mr. McMackin referenced a vacant property next to the school on Madison Avenue stating it is a chronic problem with weeds, etc. He asked to have the Property Maintenance Officer check it regularly. Mr. McMackin said there is a trailer with debris at another property on Madison. He asked about the issue at Jay's Car Care whereby there is no sidewalk and the property owner allows things to be parked right up to the street.

Mary Ann Milligan – 407 Madison Avenue. Ms. Milligan also referenced the property on Madison with the trailer of debris. She said it has been removed and replaced repeatedly. She said the owner of the property leases a majority of the building to other tenants and that there are regularly six to ten people congregating on the property looking for work.

Dominic Pistone – Dorchester Manor. Mr. Pistone asked why Shop Rite employees were able to park on Shop Rite's property prior to the renovation but now they have to park on the street. Councilman Colucci said they expect more business after the renovation. Mr. Pistone said it is a safety issue. Councilman Colucci said he had the Fire Chief go up and down the street with a fire truck and he was able to get through. Councilman Colucci said he would go back to Shop Rite to speak with management. Mr. Pistone asked about making one side of the street no parking. It was noted that this would restrict the parking for the tenants as well. Mr. Pistone commented that he did not think political signs on vehicles should be permitted on Borough property. The Borough Attorney said that this is a protected right under the First Amendment.

Being no further comment from the public Council President Duffie made a motion to close the meeting to the public. Councilman Robalino seconded the motion. All present in favor, none opposed.





Much has been made of the topic of medical benefits for Mayor and Council members since our last meeting. In order to clear up my part in this I have prepared the following statement of fact.

I have not taken medical benefits since I joined the council in year 2000. I am fortunate that the day job I have provides me with a medical benefit plan. I have taken dental benefits.

I had thought in the past that this was a personal issue, and I have declined to discuss it publicly. This has changed recently and I want to be on the record with the correct information. The results of my declination of medical benefits have had a cost savings to the Borough during the last 14 years of services of \$268K, based on figures I have taken from our risk manager.

We have discussed the idea of eliminating benefits in the past. Now the time has come where there was a will from the council to put it on the agenda. There were three different ideas put forth at the last meeting

1. Eliminate benefits and stipends
2. Eliminate benefits – silent on stipends
3. Eliminate stipends – silent on benefits

There were several votes taken on July 28th and the result of those votes was that we would eliminate health benefits (silent on stipends (option # 2). This would save 134K in the 2015 insurance line. This is without consideration to the other half of the proposal, which was to increase the stipend. I was surprised at the last meeting when CM Putrino changed his analysis to exclude the suggested stipend increases. The original proposal would have doubled the increase on the

stipend side. To ignore it in this proposal means we would be waiting for another proposal to increase the stipend.

The cost savings of eliminating benefits and/or stipends for the Mayor and Council needs to be considered together in order to calculate the true savings.
